1. Introduction

1.1 Foreword from the Chair of SACRE 2023-24

As I look back at the past academic year, I am reminded of the great loss to our SACRE which we have all felt from the death of our much-loved consultant Lesley Prior. Lesley is irreplaceable, but we have benefited greatly from the input we have received from all the members of our SACRE team, both those established over many years, and our more recent members who have brought new insights and energies to our work. Each year I record my thanks to the team for their commitment to the delivery of RE and values education in our schools. The blend of friendship, understanding and honest sharing of faith perspectives within the team, which makes our work so distinctive, is a pleasure to chair. I would also like to give particular thanks for the support we receive from Achieving for Children, which has helped us to manage our work following the loss of our consultant.

Our skilled and knowledgeable Democratic Services clerk, Joanne Tutt, continues to bring her attention to detail and thoughtful between-meetings follow up, which has enabled our SACRE to move forward with new projects, such as the RE Award for primary schools which we now offer jointly with the Royal Borough of Kingston. It was a great pleasure to attend the first award ceremony at Heathfield Junior School, in the presence of the Mayor of Richmond, and to enjoy such a vibrant school RE assembly.

The Annual Report includes an account of our third Faith Direct Day, held on 2nd July, splendidly hosted by the Head of Orleans Park School in Twickenham and with help from Year 10 students who had participated the previous year. Once again, our Faith leaders led workshops for the young people attending and then joined a panel to answer questions from the students attending. A further Faith Day is being considered for the summer of 2025 with a focus on young people attending our local schools for children with special learning needs.

In this academic year, a small group of members began the process of reviewing the delivery of RE in our secondary schools and academies, so that we are able to reflect back to Headteachers the context of their RE teaching. I am grateful for the work that has been put into this project, which will be a useful guide for secondary Heads.



2. Religious Education Statutory Responsibilities

2.1 Background

The London Borough of Richmond upon Thames' Standing Advisory Council on Religious Education (SACRE) is required, in accordance with Section 391(6) of the Education Act 1996, to publish an annual report on its activities. This report summarises its activities during the academic year 2023-24. Its current terms of reference, as laid down by the Education Reform Act 1998, are: "to advise the authority upon such matters connected with religious worship in

county schools and the religious education to be given in accordance with an agreed syllabus as the authority may refer to the council or as the council may see fit."

In particular, the SACRE is charged with the following responsibilities:

- It can require the authority to review the Agreed Syllabus on Religious Education.
- It may determine, on application by the Headteacher that the requirement for Collective Worship in community schools to be wholly or mainly of a broadly Christian character shall not apply to the Collective Worship provided for some or all of its pupils in a particular school.
- With the authority, to review the support offered for RE teaching, the methods of teaching employed, and teachers' in-service professional development.

In addition, the SACRE has a direct role in the consideration and disposal of complaints related to the RE curriculum or Collective Worship. The SACRE will be asked to advise where complaints relate to Religious Education given in accordance with the locally agreed syllabus or to Collective Worship in county – now called community – schools maintained by the LA.

2.2 Locally Agreed Syllabus

By statute, every local authority is required to adopt a Locally Agreed Syllabus (LAS) for Religious Education and to review it every five years. The current LB Richmond upon Thames LAS has been in place since February 2020 after undergoing a rigorous process of review and revision. In line with the requirement to review the Agreed Syllabus every 5 years, a refreshed Agreed Syllabus will be available in 2025.

2.3 Standards in RE

SACRE members give close consideration to the various national and local developments concerning the provision of RE. Their discussions are prompted by the information provided to the SACRE through the regular updates from teacher members, the RE Consultant and SACRE Adviser and NASACRE Briefings. During 202-24, SACRE gave particular attention to:

- the introduction of the joint RE award for Kingston and Richmond schools, the first award from which was given to Heathfield Junior School on 10 July 2024.
- planning and holding a third Faith Direct Day for 2 July 2024, which would follow on from the success of the previous 'Faith Direct' events in 2022 and 2023. The event

offered Key Stage 3 pupils opportunities to meet and talk with representatives of the religions and worldviews included in the syllabus and involving SACRE members. It had been hoped to include Special Schools in the day but it had been decided the format would be more meaningful if separate events were held for mainstream and special schools. It was therefore decided to move the Faith Direct day for special schools to the next year.

- examining the information provided by schools in response to a survey issued by the SACRE in the Autumn and Spring terms of 2023/24, to assess the level of R.E provision in the borough's secondary schools and what the barriers were to provision. This was followed by an audit, conducted by SACRE members, of the information available on secondary school websites about the provision of R.E in their school.
- consideration of Sentientism as part of the non religious worldviews represented on SACRE and in the agreed syllabus.
- consideration and discussion of the Ofsted report on provision of R.E. '<u>Deep and</u> Meaningful? The Religious Education Subject Report'

2.4 Teacher Training

A Good Practice Network for Subject Leaders for RE in community primary schools (in both LB Richmond upon Thames and RB Kingston upon Thames) continued to run in 2023-24. These sessions were led by Ian Nicholson, RE Consultant for RE Today. Occasionally SACRE members are able to be present too and play a key role in building effective links between SACRE and the members of this group.

The RE Subject Leaders in community primary schools have met three times this year.

The Primary RE Network continues to grow in size and many members maintain constant and mutually supportive contact with one another between sessions using a WhatsApp Group. This initiative has been warmly welcomed, with questions being raised, materials recommended and documentation shared.

2.5 Faith Direct Day

SACRE hosted its third 'Faith Direct Day' on 2 July 2024 at Orleans Park with representatives from nine major religions and worldviews including Buddhism, Roman Catholic and Anglican Christianity, Hinduism, Humanism, Sunni Islam, Orthodox and Liberal Judaism and Sikhism. Students attended from 7 schools: Christ's School, Grey Court School, Hampton High School, Orleans Park School, Turing House School, Twickenham School and Waldegrave School.

The day was split into five parts; a welcome, a session where the school groups each rotated to meet the seven Faith representatives in turn, lunch, question and answers with the panel and a plenary where students fedback via an online form. Feedback from students, teachers and representatives was positive and indicated that the opportunity to engage in meaningful dialogue had enhanced understanding of different beliefs.

2.6 Audit of RE Provision in Richmond Secondary Schools

During the year Richmond SACRE conducted an exercise with Richmond's secondary schools to monitor the provision of RE, and to assess the material provided on school websites about RE. We undertook this piece of work in relation to the statutory duty of SACREs to monitor the provision of RE within their local authority.

Our main objectives in conducting the survey were to

- seek to raise the status and profile of RE teaching
- seek to bring more consistency in RE teaching
- seek to help to raise standards

We prepared a report outlining our main findings, containing what we hope are helpful recommendations for schools. We also made suggestions for RE policy development within schools. The link to the report can found here.

2.7 Complaints and Withdrawals

There have been no complaints to SACRE in 2023-24 in relation to Religious Education.

SACRE has received no reports of pupils being withdrawn from Religious Education in 2023-24.

3. Collective Worship Statutory Responsibilities

3.1. Standards and Monitoring of Collective Worship

During 2023-24 the Richmond SACRE was advised by Ian Nicholson from R.E Today Services.

There have been no complaints to SACRE in 202-24 in relation to Collective Worship.

SACRE has received no reports of pupils being withdrawn from Collective Worship in 2023-24.

3.2 Determinations

A determination lifts the requirement for the majority of the statutory daily Acts of Collective Worship in the school to be "wholly or mainly of a broadly Christian character".

No LA maintained schools in LB Richmond upon Thames have ever applied to SACRE for a determination.

3.3 Other Information

The National Association of Teachers of Religious Education (NATRE) has provided Richmond with the Teaching hours analysis for schools in in the Richmond borough from the school workforce census that took place in November 2023 and which was published in June 2024. Also provided was the provisional GCSE data from summer 2024.
