1.1 Foreword from the Chair of SACRE 2022-23



Thank you, Lesley.

Supporting the SACRE team we are very fortunate to have our skilled and knowledgeable Democratic Services clerk, Joanne Tutt, whose attention to detail and thoughtful follow-up continues to ensure the success of our meetings throughout the year. This year, Joanne has played a very special role in taking on so much of the burden of forward planning and administration as we wait for the appointment of an RE Adviser to take the place of Lesley.

The Annual Report includes an account of our second Faith Direct Day, held on 4th July, splendidly hosted by the Head of Christ's School in Richmond. This year the day was extended with an invitation to our Faith leaders to form a panel to answer questions from the students attending, which stimulated some very reflective responses from the leaders to current issues. Our Humanist member Jon Fayle once again led our planning, well supported by members of SACRE both in the planning and on the day itself. A further Faith Direct Day is being considered for the summer of 2024.

The number of members of our SACRE continues to grow, and the commitment and friendship of our group is undiminished. The Annual Report gives a flavour of our approach to the important SACRE role of maintaining standards in RE, and our new joint work with our counterpart SACRE in the Royal Borough of Kingston will enable our primary schools to grow and flourish in their delivery of RE.

2. Religious Education Statutory Responsibilities

2.1 Background

The London Borough of Richmond upon Thames' Standing Advisory Council on Religious Education (SACRE) is required, in accordance with Section 391(6) of the Education Act 1996, to publish an annual report on its activities. This report summarises its activities during the academic year 2022-23. Its current terms of reference, as laid down by the Education Reform Act 1998, are: "to advise the authority upon such matters connected with religious worship in county schools and the religious education to be given in accordance with an agreed syllabus as the authority may refer to the council or as the council may see fit."

In particular, the SACRE is charged with the following responsibilities:

- It can require the authority to review the Agreed Syllabus on Religious Education.
- It may determine, on application by the headteacher that the requirement for Collective Worship in community schools to be wholly or mainly of a broadly Christian character shall not apply to the Collective Worship provided for some or all of its pupils in a particular school.
- With the authority, to review the support offered for RE teaching, the methods of teaching employed, and teachers' in-service professional development.

In addition, the SACRE has a direct role in the consideration and disposal of complaints related to the RE curriculum or Collective Worship. The SACRE will be asked to advise where complaints relate to Religious Education given in accordance with the locally agreed syllabus or to Collective Worship in county – now called community – schools maintained by the LA.

2.2 Locally Agreed Syllabus

Official

By statute, every local authority is required to adopt a Locally Agreed Syllabus (LAS) for Religious Education and to review it every five years. The current LB Richmond upon Thames LAS has been in place since February 2020 after undergoing a rigorous process of review and revision.

2.3 Standards in RE

SACRE members give close consideration to the various national and local developments concerning the provision of RE. Their discussions are prompted by the information provided to the SACRE through the regular updates from teacher members, the RE Consultant and SACRE Adviser and NASACRE Briefings. During 2022-23, SACRE gave particular attention to:

- the impact of potential increased academisation of schools and strategies to promote best practice in R.E. Members were of the view that Ofsted had a role to play in enforcing R.E provision and would welcome more 'deep dives' in R.E being undertaken as part of Ofsted inspections.
- the introduction of a joint R.E award for Kingston and Richmond schools. Members were aware that schools were sometimes discouraged from applying for the national

R.E Quality Mark as the cost and standards required were prohibitive. Therefore it was agreed to provide a local R.E award by extending the Kingston R.E Award to Richmond schools.

- planning and holding a second Faith Direct Day for July 2023, which followed on from the success of the first 'Faith Direct' event in July 2022. The event offered Key Stage 3 pupils opportunities to meet and talk with representatives of the religions and worldviews included in the syllabus and involving SACRE members
- examining the information provided by NATRE on the hours spent teaching R.E in the borough's secondary schools. Members discussed the SACREs capacity to undertake monitoring of R.E in schools and the began planning a SACRE subgroup to engage with secondary schools.
- examining the newly released 2021 Census data on religious affiliations in the borough, which most notably showed a decline in those described themselves as Christian and a rise in those describing themselves as having no religion. Only slight percentage changes were noted in the other religious categories.

2.4 Teacher Training

Official

A Good Practice Network for Subject Leaders for RE in community primary schools (in both LB Richmond upon Thames and RB Kingston upon Thames) continued to run on a termly basis in 2022-23. These sessions were led by Lesley Prior, RE Consultant and Adviser to the SACRE until January 2023, when the role was taken over by Insight. Occasionally SACRE members are able to be present too and play a key role in building effective links between SACRE and the members of this group.

The RE Subject Leaders in community primary schools have met three times this year.

- 8th November 2022, focusing on:
 - R.E in the Early Years Foundation stage and assessment and progression in R.E
- 9th March 2023:
- 13th June 2023, focusing on:
 - \circ The Bible and the trinity

The Primary RE Network continues to grow in size and many members maintain constant and mutually supportive contact with one another between sessions using a WhatsApp Group. This initiative has been warmly welcomed, with questions being raised, materials recommended and documentation shared.

2.5 Faith Direct Day

SACRE hosted a second 'Faith Direct Day' on 4 July 2023 at Christs School with speakers from the seven major religions and worldviews. The event was attended by five secondary schools, enabling over fifty Key Stage 3 students to join the event.

The schools received a briefing pack ahead of the event so that the students could come prepared with questions to delve as deeply as possible into each religion and belief. Students had twenty minutes to ask questions and share thoughts with each of the speakers, before returning to their own schools to share their learning with their peers.

The speakers and represented religions and beliefs were:

- Humanism Jon Fayle (Humanists UK)
- Islam Rashid Ali Laher (Kingston Mosque)
- Buddhism Madara Sathyendrakumar, Ven Seelawimala (London Buddhist Vihara)
- Sikhism Charanjit Ajitsingh, Barinder Sandhu (Hounslow Sikh Gurdwara)
- Hinduism Jitubhai Dave (Hanuman Hindu Temple)
- Judaism Chaim Golker, Councillor Jo Humphreys (Richmond Synagogue)
- Christianity Eseabasi Ntefon, (Holy Trinity Church, Richmond)

The event encouraged dialogues discussion through thought-provoking questions to promote understanding and cohesion of others' points of view.

The event was attended by local MP Sarah Olney and the Deputy Leader of Richmond Council Cllr Jim Millard.

2.6 Complaints and Withdrawals

There have been no complaints to SACRE in 2022-23 in relation to Religious Education.

SACRE has received no reports of pupils being withdrawn from Religious Education in 2022-23.

3. Collective Worship Statutory Responsibilities

3.1. Standards and Monitoring of Collective Worship

During 2022 the SACRE Adviser Lesley Prior continued to offer advice and support on Collective Worship to staff in schools who have requested this until her retirement at the beginning of 2023.

3.2 Determinations

A determination lifts the requirement for the majority of the statutory daily Acts of Collective Worship in the school to be "wholly or mainly of a broadly Christian character".

No LA maintained schools in LB Richmond upon Thames have ever applied to SACRE for a determination.

3.3 Other Information

There have been no complaints to SACRE in 2022-23 in relation to Collective Worship.

SACRE has received no reports of pupils being withdrawn from Collective Worship in 2022-23.

4. Links with other Bodies

LB Richmond upon Thames SACRE is affiliated to The National Association of SACREs (NASACRE) and notes and discusses key points from its regular briefings.
