Words from the Chair - Miss C Hughes

St Helens SACRE continues to become more effective in its organisation and management and continues its drive to improve and support Religious Education in St Helens. We have utilised the strengths of our faith representatives to lead staff CPD during Inter Faith week, this is something we want to build on. Each meeting has a clear focus with standard agenda items including the development plan. We have introduced a termly headteacher newsletter — SACRE spotlight. The purpose of this is to showcase the good RE that is happening in our schools but also to raise the profile of SACRE and to communicate any national issues and developments. We have also done work on the 2021 census to ensure our membership reflects the demographics of our local area, we are aware of the changing local society and to ensure our AS is relevant.

St Helens SACRE is also beginning to have a national voice through being on BBC Radio 4 Sunday programme and having a member on the NASACRE Executive board. This will help raise our profile and enable us to share the good practice that we are currently doing.

We continue to have a clear vision and will continue to strive to support excellent Religions Education for all our students in St Helens.

To complete this report, all members are invited to contribute and a headteacher survey is used.

Our key priorities from last year's report were as follows:

Key priority 1: Determination policy to be produced and shared with all schools

Determination policy has been produced by St Helens SACRE and shared with all St Helens schools.

Key priority 2: To improve attendance and hold hybrid meetings

We have held the meetings hybrid and also changed the times to try to improve attendance at meetings. This is something we need to continue to work on next year. Next year we are looking at the timing of the meeting as well as putting the dates on the council website.

Key priority 3: To explore membership for other faiths and other educational providers We have explored the membership of our SACRE to reflect our demographics. We have appointed a new member for group B (Church of England), group C (Teacher associations – from a ITT college). We have also started to make link for representative of group A (other faiths) for Hinduism and Humanism. We will also appoint a vice chair in the September 2023.

Section 2: RE

St Helens SACRE has supported the RE provision in St Helens by the following activities:

- There have been RE lead meetings run by the Chair. All meetings are an opportunity
 to share good practice, recent research, CPD opportunities and to focus on the AS.
 The minutes are shared with all members of SACRE and all RE leads in the borough.
- The Chair shares resources and CPD events to all RE leads when appropriate.
- For Inter Faith week we lead a week long CPD event and provided resources for schools for collective worship. Each day focused on a different worldview, the CPD matched that evening. Various faith representative from St Helens SACRE lead the CPD which all schools were invited to attend.
- St Helens SACRE conducted a **student voice survey**. 8 primary schools and 1 secondary school took part. This was positive and questions linked to a national survey for comparison. This is something we are looking to develop next year.
- One secondary school took part in a parent survey as part of a research project lead by the chair. This was extremely positive and shared with all SACRE members.
- There is only 1 withdrawal from RE
- OFSTED reports monitored for links to Religious Education (see appendix)

St Helens SACRE Determination Policy - 2023

Introduction

The law requires all schools that do not have a religious foundation to provide "a daily act of collective worship" for all pupils in the school, other than those withdrawn at the request of their parents.

Where a headteacher considers that the requirement to provide worship that is wholly or predominately Christian could conflict with the requirement to provide worship that accords with the family backgrounds of pupils, schools can apply for a determination to lift or modify the requirement.

Maintained schools should apply to St Helens SACRE and academies should apply through the Education and Skills Funding Agency. Before requesting a determination, a headteacher must consult the school's governing board, who in turn may wish to seek the views of parents. The headteacher's application may relate either to a clearly described and defined group or to the whole school.

Process

Any LA school seeking to apply for a determination should complete the attached form and send it with the required accompanying documents to the email address provided, for consideration by SACRE. Completed applications should be with the SACRE Clerk at least SIX weeks before the SACRE meeting that will consider the application. Southampton SACRE meets at least once a term and so the determination discussion and decisions will be taken to the next available meeting. SACRE will seek to respond within 3 weeks of that meeting. The response will either be to grant or deny the application for a determination or may request further information. Schools are strongly advised to have consulted with SACRE's professional adviser in advance of making an application.

Application

Applications for a determination can only be made by the head teacher of the school. If a school is considering making an application the head teacher must consult the school's governing body, who in turn should seek the views of all parents. It is advised that this consultation is undertaken with the involvement of SACRE professional adviser.

In order to apply for a determination, the Headteacher should consult with governors, parents, and staff, all of whom will need the following information to guide their decisions:

• A statement from the school as to why the 'wholly or mainly broadly Christian character' of Collective Worship is not appropriate (for all or part of the school)

- What is known about the heritage and background of pupils at the school
- Clear information about what the alternative form of collective worship would be and to whom it will apply
- The number of withdrawals from broadly Christian acts of Collective Worship
- The school's current policy on Collective Worship, and how parents from all backgrounds were engaged in drawing up the policy
- Any other information that the Headteacher considers may be appropriate to supporting the application, e.g. relevant paragraphs from the school's OFSTED report
- Governors and parents should also be given the opportunity to see collective worship in the school, should they wish.
- Governors must vote at a meeting of the full governing body. Parents and teachers should be given the opportunity to vote in a secret ballot.

This evidence to be shared with St Helens SACRE to enable a decision to be made.

How a decision will be made

Once the application and accompanying documentation has been received by the SACRE, an agreed representative group of SACRE members will hold a preliminary meeting before the next SACRE. This group will be convened as required by the professional adviser to SACRE and consist of a representative of each of SACRE group + one co-opted member + SACRE Professional Adviser(s). If there is insufficient time to convene this group before the next SACRE meeting, then a recommendation regarding the determination will be put before the following SACRE meeting as a confidential item.

Information about new arrangements for Collective Worship in the school should be published in the school prospectus. This information should also be made available to Ofsted.

SACRE must review its determination if the school so requests and, in any event, within five years of the date when the determination was made or last reviewed.

St Helens SACRE - OFSTED Report's 2022-23

In 2022 – 23, **19 schools / educational establishments** in St Helens were inspected by OFSTED. Here are examples in the OFSTED reports of statements linking to Religious Education, collective worship and British Values:

Merton Bank (Nov 22)

Pupils are welcoming towards visitors, but some pupils lack sufficient awareness of people with different backgrounds, religions and families. This hinders their readiness for life in modern Britain.

Queen's Park CofE/Urc Primary School (Jan 23)

Leaders encourage pupils to act as courageous advocates in school. Pupils develop as active citizens through their work with international schools.

Leaders have constructed a comprehensive curriculum to support pupils' personal development. For example, pupils learn about different families, world religions and how to keep themselves healthy. This prepares them well to take their place in modern Britain.

St Helens College (February 23)

Teachers routinely model and promote fundamental British values and equality and diversity effectively in their lessons.

Eaves Primary School (February 23)

Pupils show respect towards each other. There is an understanding of the importance of being tolerant of people's differences.

Pupils learn about diversity and celebrate different cultures and societies. They speak about the importance of treating everyone with kindness and respect.

Carr Mill Primary School (March 23)

Leaders enliven the curriculum and broaden pupils' horizons. Year 6 pupils enjoy their annual London excursion, where they visit London landmarks including Westminster Abby. Pupils learn about, and develop a strong appreciation of, cultural and religious diversity.

De La Salle School (June 23)

Pupils learn about different faiths and religions. This helps them to develop an understanding and respect for those who might have different beliefs from their own.
