#### 1. Introduction

#### 1.1 Words from the Chair

This past couple of years have seen some challenging obstacles as the pandemic impacted upon all aspects of life. Warrington SACRE continued to meet during this reporting period over Microsoft Teams/Zoom and we have all learnt many new skills because of this. We are thankful for the technical support afforded to us whilst recognising that some members may have found this challenging.

Continuing as chair, this year has been one of reflection and planning for new opportunities in the face of a challenging time for everyone. Despite the impact of Covid-19 and the lock down measures Warrington Schools have continued to provide high quality education and support to students and staff and this should be recognized. We paused some of the work we would normally do over this period such as monitoring visits to schools as it would not have been appropriate to have carried this work out within the government guidelines at the time. So, it has been a much quieter year in some aspects, but slowly we have been able to reintroduce visits and have carried some out via virtual platforms.

The Self-evaluation tool is a priority for SACRE to use over the coming two years so as to ensure recovery from the pandemic period is effective and SACRE remains an effective body.

We have always been a well-attended SACRE and this was not diminished throughout lockdown as members continued to meet. The membership reflects the diversity of the wider religious and professional community of Warrington and we are seeking to recruit a member from the Jewish community to further represent the wider regional community. SACRE meetings are representative, engaging, and productive. We have said goodbye to a long-standing, highly valued member in this period – Cathy Taylor –to all of whom we give thanks for her service and commitment to the SACRE in Warrington.

As Chair I am incredibly grateful to all who have positively embraced the new ways of meeting and demonstrated their commitment to support SACRE through these the most challenging of times. We look forward, to be able to report further progress of our work in the report next year as we implement the new self-evaluation tool and development plan.

## 2. Religious Education (statutory responsibilities)

In Warrington all maintained schools follow the Lancashire Agreed Syllabus, as adopted by Warrington SACRE members. A number of academies also purchase the syllabus.

The Lancashire Agreed Syllabus was revised and adopted by Warrington SACRE for a further five years in the autumn 2020

# 2.1 Standards and monitoring of RE

SACRE typically uses several methods to monitor standards and the quality of provision. For example:

- Requesting the completion of an annual questionnaire to check statutory duties and feedback from schools
- Undertaking virtual school visits

During 2020/2021 opportunities to monitor provision were stopped due to the pandemic. As assessments were cancelled for the second time, it was deemed inappropriate to gather assessment data from schools.

All Warrington Schools were requested to complete the annual return in order to capture a full and comprehensive picture of Religious Education and Collective Worship. 51 schools responded (include the % and how many out of), made up of 49 primary schools, 2 secondary schools and no special schools.

#### 2.2 Religious Education provisions in schools: Of the 51 schools who responded

- 100% of schools regularly monitor, review and evaluate RE provision in their school
- 100% of schools have daily act of worship in line with statutory requirements
- 81% of schools regularly monitor, review and evaluate collective worship provision
- 100% allocate at least the minimum recommended RE entitlement across KS1 KS2. Of the 9 secondary schools who responded 3 did allocate the recommended time and 4 didn't in KS3 – KS4.

## 2.3 Teacher training and materials for schools

There were no network meetings held.

# 2.4 Other information (withdrawls, complaints, teacher recruitment & retention)

SACRE has a role in investigating complaints against schools in relation to RE and Collective Worship. No complaints were received in 2020/2021.

The Local Authority didn't receive any requests for information under the FOI act.

There were no requests for children to withdraw from RE.

## 3. Collective Worship

#### 3.1 Standards and Monitoring of Collective Worship

The schools' self evaluation of the standards and monitoring of collective worship was:

- Outstanding 14 out of 51
- Good 25 out of 51
- Satisfactory 10 out of 51
- Inadequate 0 out of 51
