We are very grateful to Patricia Hannam of Hampshire LA and Lesley Prior, our SACRE advisor, for working with us to develop a version of the Hampshire syllabus 'Living Difference III' for our multi-faith, urban context. We took the whole year to engage with this process thoroughly, to get the right solution for our schools, and we look forward to launching the revised syllabus in 2018, and providing training for the teachers who will be using it.

We enjoyed hearing the feedback from our Vice Chair on the NASACRE annual conference in York, and I was honoured to be elected to the NASACRE executive this year. I am hopeful that what I learn about good practice from around the country and about the national picture for RE will help us locally to support our schools here in Westminster.

It is a privilege to be able to work with such a diverse group of people, who hold a wide range of beliefs, but with the shared goal of high quality Religious Education for our young people and ever-increasing understanding of each other's views and lives.

## Background

This report summarises the activities of the City of Westminster Standing Advisory Council on Religious Education (SACRE) during the academic year 2016 – 2017. The SACRE has a remit for monitoring Religious Education and Collective Worship in nondenominational schools. The relevant diocesan authorities monitor denominational schools. The Education Act 2002 requires that Religious Education must be provided as part of the basic curriculum in addition to the National Curriculum. Parents have the right to withdraw their children from all or part of RE and are not obliged to state their reasons for withdrawal.

This report is composed in the light of guidance from the National Association of SACREs (NASACRE) on the format of SACRE annual reports.

## 1. Religious Education

#### 1.1 Locally Agreed Syllabus

By statute, every local authority is required to adopt a Locally Agreed Syllabus (LAS) of religious education and to review it every five years. The current Westminster LAS was originally adopted in 2006, when it was adapted from the Hampshire LAS to make it more suitable for Westminster schools. It was reviewed in 2011 and agreed without any changes. At the SACRE meeting of 29<sup>th</sup> June 2016, members unanimously agreed that the Local Authority should be asked to establish an Agreed Syllabus Conference (ASC) to review the syllabus.

An Agreed Syllabus Conference was convened and had its first meeting in November 2016 to carry out the review of the Agreed Syllabus. The Conference met every term throughout 2016-17 and also set up a working party which met separately.

It was agreed to adopt the Hampshire RE Syllabus – *Living Difference III*, which the previous Syllabus was based on and to make it specific to The City of Westminster. As a result, the working group proposed a range of changes, which were recommended to the Agreed Syllabus Conference in June 2017. The members voted unanimously in their committees to agree these changes. The Agreed Syllabus document will be finalised in the autumn term of 2017-18 and given to the Cabinet Member for approval. This will then be followed up by a formal launch and training for RE teachers.

#### 1.2 Standards in RE

SACRE members gave close consideration to the various national and local developments concerning the provision of RE and continue to do so.

SACRE members and the SACRE Consultant offered school based colleagues advice, help and support during the year, reflecting the requirements of the agreed syllabus and pertinent to the individual needs of each school.

## **1.3** Methods of Teaching, the Choice of Teaching Materials, Teacher Training

An RE Good Practice Network had been established for teachers in the Tri-Borough of Westminster, Kensington and Chelsea and Hammersmith and Fulham. Issues addressed in 2016-17 were assessment in RE and Collective Worship.

#### **1.4 Matters Discussed During the Year**

- A new NASACRE Constitution. Westminster SACRE members voted to adopt the proposed Constitution;
- Review of the legal, education, and policy frameworks for RE by the Commission on RE.

## 1.5 Complaints Concerning RE

No complaints were received by SACRE in 2016-2017.

## 2. Collective Worship

#### 2.1 Advice on Collective Worship and Determinations

Any school applying for or renewing a Determination should receive a visit from SACRE members prior to the application being discussed at a meeting.

#### 2.2 Determinations

There were no new applications for a Determination in 2016-17. There are currently three schools with a Determination:

Determinations are for a period of five years. The Determination granted to Hallfield Primary School will therefore be lapsing in February 2018.

#### 3. Links with Other Bodies

The City of Westminster SACRE is affiliated to The National Association of SACREs (NASACRE).

John Hicks, Vice-Chair of SACRE, represented The City of Westminster SACRE at the NASACRE AGM and Conference *Preparing for life in Britain today: the contribution of RE* in York on 16<sup>th</sup> May 2017.

There were two key note speakers.

Dr Joyce Miller is one of the Commissioners serving on the RE Council's Commission on RE. She highlighted the key reports on RE published in recent years and gave an overview of the work that the Commission was focusing on. Dr Miller also introduced some relevant contradictions relating to life in modern Britain such as religiosity and secularity, globalisation and atomisation, convergence and divergence, etc., and discussed the implications they had for RE.

Aaqil Ahmed is a former head of Religious Programming at both Channel 4 and the BBC. He talked about a lack of religious literacy in wider society. His policy was to promote a learning journey and for all public bodies to have a religious literacy initiative in place which would be monitored and regulated in some way.

It was also announced at the Conference that Emily Norman, Chair of Westminster SACRE, had been appointed to the NASACRE Executive Committee.

Lesley Prior, the SACRE Consultant for Westminster, is now Assistant to the NASACRE Executive Group. She also attended the Conference and AGM.

Before November's meeting, several SACRE members from Committee A resigned from their membership. These were Lesley Taherzadeh O'Mara (Baha'i), David Quoroll (Society of Friends), Sophie Dunoff (Jewish Faith) and Hilary Sewell (Baptist Church).

In September 2016, Dawn Waterman was appointed to represent Jewish Faith in Committee A to replace Sophie Dunoff.

At the meeting on 1<sup>st</sup> November 2016, John Hicks (Committee B – Church of England) was appointed as the new Vice Chair to replace Elizabeth Wolverson who stood down in June 2016.

In December 2016, Katy Parsi-Boetig was appointed to represent Baha'i Faith in Committee A to replace Lesley Taherzadeh O'Mara.

At the meeting on 20<sup>th</sup> February, Darren Gattridge was welcomed to represent the NAHT in Committee C in place of Naomi Leaver.

At the meeting on 14<sup>th</sup> June 2017, the members agreed to co-opt two new members to Committee C (Teachers) – Fiona McTaggart and Hayat Boujettef, teachers at Gateway Academy and Edward Wilson Primary School respectively. Both are registered with the National Union of Teachers.
