# **Background**

This report summarises the activities of the Westminster Standing Advisory Council on Religious Education (SACRE) during the academic year 2021-22. The SACRE has a remit for monitoring Religious Education and Collective Worship in non-denominational schools. The relevant diocesan authorities monitor denominational schools. The Education Act 2002 requires that Religious Education (RE) must be provided as part of the basic curriculum in addition to the National Curriculum. Parents have the right to withdraw their children from all or part of RE and are not obliged to state their reasons for withdrawal.

This report is composed in the light of guidance from the National Association of SACREs (NASACRE) on the format of SACRE annual reports.

# 1. SACRE Arrangements

The Westminster SACRE met on the following occasions in 2021-22:

- 14 December 2021
- 24 March 2022
- 28 June 2022

SACRE meetings are usually hosted by the Local Authority or the SACRE members in venues across Westminster. Due to restrictions and safety precautions related to Covid-19, the autumn term meeting was held virtually while the other two were held as hybrid meetings allowing for both in-person and online attendance.

Secretarial assistance and a budget for the discharge of the SACRE's duties is provided to the SACRE by Westminster City Council. The key areas of this support include the following:

- Provision of a clerk
- Provision of a Local Authority Adviser
- Commissioning of an RE Consultant
- Funding of the NASACRE annual membership
- Funding of the NASACRE annual training offer
- Funding for two SACRE members to attend NASACRE's annual Conference and AGM when it is held in-person, or equivalent funding for SACRE members to attend the Conference should it be held virtually
- Costs relating to establishing and reviewing a Locally Agreed Syllabus (when appropriate)

Professional support was provided by SACRE Consultant Lesley Prior on a consultancy basis.

# 1.1 Membership Updates

Autumn Term 2021

 Myles Owen was appointed to represent the London Diocesan Board for Schools on Committee C.

# Spring Term 2022

- Mary Wilson was appointed to represent the RC Diocese of Westminster on Committee A.
- Shirin Rose King was appointed to represent Baha'i Local Spiritual Assembly of Westminster on Committee A.

### Summer Term 2022

- James Spencer representing the Local Authority on Committee D was not re-elected as a councillor during the local council elections in May 2022. His term of office also finished in the same month, which made him ineligible for the SACRE membership under Committee D.
- Daniel Hirschfield was nominated by the Board of Deputies of British Jews to replace Sandra Teacher on Committee A. Daniel's formal appointment as a SACRE member on Committee A was temporarily put on hold while the appointment process in Westminster was still being confirmed following the change in local council administration. Daniel was invited to attend the SACRE's summer term meeting as an observer while the above was being clarified.

### 1.2 Chair and Vice-Chair Elections

As specified in the Westminster SACRE Constitution revised in the autumn term 2020, Chair and Vice Chair need to take place an annual basis in the autumn term.

In 2021-22, both Chair and Vice-Chair annual elections were postponed from Autumn 2021 to Spring 2022 as the SACRE meeting in December 2021 was not quorate. The elections took place at the SACRE meeting in March 2022 with the following outcome: Councillor James Spencer was re-elected as Chair and Linda Ulrich was elected as Vice-Chair.

At the SACRE's meeting in June, Linda Ulrich was confirmed as Acting Chair following the change in James Spencer's membership as mentioned in Section 1.1 just above.

# 2. Religious Education

# 2.1 Locally Agreed Syllabus

By statute, every local authority is required to adopt a Locally Agreed Syllabus (LAS) of religious education and to review it every five years. The current Westminster LAS was adopted in Autumn 2017 from *Living Difference III*, the syllabus devised by Hampshire, Portsmouth, Southampton and the Isle of Wight. At the time, Hampshire's parent syllabus *Living Difference III* was revised for the London context, and so it was the London version of *Living Difference III* that was adopted by Westminster.

The Westminster LAS: Living Difference III is available on the Westminster SACRE website - <a href="http://services2schools.org.uk/Page/15387">http://services2schools.org.uk/Page/15387</a> - along with a number of useful links to materials/websites/films that Westminster SACRE members had compiled together to help schools in teaching RE.

Westminster's LAS will be due for review in the academic year of 2022-23. Groups A, B and C will need to vote for a recommendation to the Local Authority to establish an Agreed

Syllabus Conference (ASC) for the review of the syllabus at the SACRE meeting in Autumn 2022. As Group D is the Local Authority, it does not get a vote. The voting was originally planned for the SACRE's meeting in June 2022; however, it did not take place as the meeting was not quorate.

Hampshire reviewed their parent syllabus *Living Difference III* in 2021, which resulted in the *Living Difference IV* edition coming out in November 2021. They agreed to give a presentation on *Living Difference IV* on 8 September 2022 to share an overview of how it differed from *Living Difference III* and what deals they could offer to local authorities considering adopting it. The Westminster SACRE members agreed it would be important to attend this to familiarise themselves in more detail with the changes made to the parent syllabus. RE teachers would also be invited to this session. Hearing from Hampshire will be helpful for when the ASC is finally convened to carry out the review of the Westminster LAS.

### 2.2 Standards in RE

SACRE members gave close consideration to the various national and local developments concerning the provision of RE. These discussions were prompted by the information provided to the SACRE through the regular updates from the RE Consultant on the SACRE and NASACRE Briefings.

# 2.3 Methods of Teaching, the Choice of Teaching Materials, Teacher Training

The RE Good Practice Network, which had been previously established for teachers in Westminster and Kensington and Chelsea, continued to run on a termly basis in 2021-22 with sessions in December, March and June. These sessions are run by Lesley Prior, RE Consultant on the SACRE.

The RE Good Practice Network sessions serve as an opportunity for RE teachers and coordinators to discuss any challenges they face and to receive relevant support, for example, around Ofsted's deep dives in RE, assessment and attainment in RE, measuring and recording outcomes in RE, etc.

# 2.4 Matters Discussed During 2021-22

Key matters included the following:

- Review of *Things of the Spirit*, Westminster's guidance for Collective Worship, and progress updates
- Review of the Locally Agreed Syllabus (please also see Section 2.1 above)
- The Education White Paper and its implications on RE and the work of SACREs
- Quality RE in academies and further ideas around the work of the Academies Working Group
- SACRE self-evaluation using NASACRE's self-evaluation tool
  - The SACRE concluded it was well resourced. It has support from the Clerk, the LA Adviser and the RE Consultant, who is funded by the LA. Some areas for development were identified during this discussion at the summer term meeting and plans were made to look in the new academic year at possible projects that the SACRE could take up.

In addition to the above discussion, arrangements were made for members Linda Ulrich, John Pearson-Hicks and Cllr Ruth Bush to meet separately in August to go through the NASACRE's self-evaluation form in more detail with a view to presenting their initial thoughts to the wider group in Autumn 2022.

### - Census 2021 results

It will be important to review them for the local context once the break down of the results is available in Autumn 2022. The SACRE's composition (especially Committee A) would need to be reviewed accordingly.

In setting up agendas for the termly Westminster SACRE meetings in 2021-22, consideration was given to NASACRE's recommendations for agenda items as suggested in NASACRE's regular briefings.
