Chair's Introduction

In SACRE terms it has been a relatively quiet year after last year's work on the revisions to the Agreed Syllabus and launch conference for RE teachers.

A working group looked at updating advice for Collective Worship which should be on the website soon.

Another group has worked through the NASACRE self-evaluation tool. In the main, we judged our SACRE as 'established' but this does not mean that we should not work towards improvement. This exercise will no doubt add to the discussion of what exactly is the role of SACRE in this ever-changing world.

We have resumed monitoring of school websites in order to see where the new syllabus is being put to work. The results are limited. I found that the quality of websites varied enormously and that some appeared to bury the information I was seeking. I would like to see the curriculum and class timetables easily found and understood, not just for RE but for all subjects.

A working group of teachers has taken on the task of writing advice on how we can find out more about and measure the quality of the teaching of RE in our area. They will report next year. We hope their report will assist SACRE in advising Cambridgeshire County Council on more targeted support for teachers.

There has been inevitable turnover of SACRE members We said goodbye to several people who have been on SACRE for many years and we thank them for their service and insight. I expect to be welcoming new faces in the autumn. Sadly, meetings are not always quorate despite dates of meetings being agreed months in advance. This appears to be a particular problem for Committee D.

I attended the NASACRE conference in York. Amand Fitton, our RE Adviser, was also there wearing several of her SACRE hats. The conference has had mixed reviews but it was good to have time to talk with members of other SACREs and to hear of the challenges facing them.

Management of SACRE

Cambridgeshire County Council has continued to support the work of SACRE through funding that provides a clerk for the meetings, services of an RE Adviser to support SACRE, its work and teacher training for the teaching of Religious Education, and advice about Collective Worship. The Religious Education Adviser, Amanda Fitton, has continued to work with all the Cambridgeshire schools and SACRE.

Every Local Authority has to convene a Standing Advisory Council on Religious Education (SACRE). Cambridgeshire SACRE, which has met three times this year, comprises four statutory groups. Attendance at meetings has been variable however all committees are well represented.

The four groups that make up SACRE are as follows:

- Committee A representatives of non-Anglican Christian denominations, other religions, and world-view communities;
- Committee B representatives of the Church of England;
- Committee C representatives of the teachers' associations;
- Committee D representatives of the Local Authority.

Overview and attendance at meetings

Membership, representation & recruitment - quoracy, issues and successes with recruitment –

Although it continued to be difficult to find representatives for some faiths in Committee A, generally SACRE membership is good. It has been particularly pleasing to have several RE teachers wishing to join SACRE. As the number of full members on Committee C is limited by the Constitution, several have been co-opted to SACRE. Committee D (The County Council) has been much better represented than in earlier years.

All meetings were quorate and went ahead. All meetings were held remotely or face to face.

Statutory Responsibilities

Agreed Syllabus – It is unclear how many academies are using the agreed syllabus. Monitoring has begun in 2023-2024 and there are plans for a working group to convene to consider the data.

The new Agreed Syllabus was launched in September 2023 for all schools in Cambridgeshire.

Standards and Monitoring of RE

School website monitoring was held this year and a basic analysis has been collated. This will be analysed further by the SACRE working party.

The exam results for GCSE Religious Studies have not yet been formally published and as such we are unable to report on the 2023-24 data pertaining to the thirty-three secondary schools in Cambridgeshire. This information will therefore be included within next year's annual report.

Teacher training and materials and advice for schools

Teacher training has been carried out by the RE adviser for Cambridgeshire and advertised through School News. The following training courses in 2023-24 were scheduled and were held at either Buckden Village Hall or remotely via Teams.
