# **SACRE Responsibilities**

#### 1. Collective Worship in community schools

This year SACRE considered what constitutes Collective Worship with a view to advising schools on ways they might improve their statutory responsibility to deliver it.

### 2. Religious Education (RE)

- Updated and published a new Agreed Syllabus for RE
- Through the LA arranged the annual conference for teachers of RE

#### 3. To allow any exception to the law that Collective Worship be broadly Christian

SACRE has received no requests for an exemption from the law

#### 4. To hear any complaints

SACRE hears any complaints brought to the LA about RE and collective worship. No complaints from parents were received this year.

#### The SACRE Action plan identifies that the main areas of focus for 2012-2013 will be:

- Updating SACRE's advice to schools on Collective Worship
- Providing resource materials for schools to support their implementation of the Agreed Syllabus e.g. perhaps a KS2-3 transition unit and an EYFS unit. This is in response to the feedback from teachers received during and after the official launch of the revised Agreed Syllabus for RE.

# What is the SACRE Budget?

SACRE's budget covers the cost of meetings, venue expenses, supply cover costs for teacher members, postage, photocopying, travel expenses, and subscription costs for membership of national organisations for RE. Additional resources are obtained from the County Council when necessary for the review, development and publication of the revised Agreed Syllabus.

In the financial year 2011-2012 the total amount spent was £2294: Supply cover £300; Travel expenses £372; Refreshments £38; Postage £283 (includes posting the Revised Agreed Syllabus to schools), Conference fees £980; Accommodation £55 and Subscriptions £95. An additional amount of £3762 was spent on the printing of the Revised Agreed Syllabus for RE.


