Annual Report 2021/2022

This report covers the work of the Cumbria SACRE for the period September 2021 to August 2022

#### 1. Words from the Chair

Cumbria SACRE has continued to go from strength to strength during 2021-2022. At the start of the year, we saw pupils fully return to schools after four terms of disruption to learning as a result of the pandemic. It has been encouraging to see schools begin to open up for RE visits and visitors, with several Cumbria SACRE members making virtual and face-to-face visits. The Virtual Voices in Religious Education (VVRE) project (see section 5) has engaged a wider group of RE visitors and increased activity with schools through events and CPD. The VVRE project has enabled Cumbria SACRE to raise its profile more on a national level, engaging with the shift towards an education in religion and worldviews. We are delighted to increase our membership this year to include, for the first time, local representation recommended by the Hindu Education Board.

At the end of the spring term, we said goodbye to our longstanding and valued LA officer, David Salmon. He was replaced by Senior Advisor, Gerry Ball, who continues with the mantle in making sure Cumbria SACRE can fulfil its statutory responsibilities and is well supported by the LA. Cumbria is currently undergoing a Local Government Re-organisation (LGR) into two unitary authorities by April 2023. This has been a regular item on Cumbria SACRE agenda for the last year, and members are continuing to be involved liaising with NASACRE and the LA to navigate this change, and what it means for Cumbria SACRE.

We have continued to offer online CPD for RE and were delighted to be able to hold our first face-to-face annual primary RE conference for two years. In the summer term, we convened an Agreed Syllabus conference with members and teachers.

Finally, I am thrilled to have been one of eight teachers selected for the Culham St Gabriel's Trust RE Leadership Programme Stage 2 for 2022-2023. I look forward to developing my skills and expertise at a regional and national level and I am confident this will benefit Cumbria SACRE as we navigate some significant changes over the coming year.

- Organising the annual Cumbria SACRE RE conference to launch the new Agreed Syllabus
- Completing of the Virtual Voices in Religious Education (VVRE) project in conjunction with staff from Cumbria Development Education Centre (CDEC)
- Continuing to increase teacher awareness of SACRE through newsletter, social media and other LA channels, including School Improvement and Governor Services
- Provision of school and governor CPD on the revised Agreed Syllabus
- Provision of a needs based CPD programme for RE 2022-23 in line with other LA subject offers
- Continuing to raise profile and involvement in National Association for SACRE and other national RE organisations.
- Engagement with the new regional RE Hubs
- Continued involvement with Cumbria Development Education Centre, developing their website support for RE
- Continuing to engage with RE teachers across Cumbria through CPD and online channels

#### Religious Education Quality Mark - REQM

Schools can apply for three levels of the REQM award. A school's evidence and provision are assessed by an external assessor, against nationally recognised criteria. Cumbria SACRE encourages all schools, via termly newsletter and during CPD, to access the REQM assessment materials to use as an audit tool, even if they feel the time and cost of full accreditation is not an immediate priority. #### 3. A section on CW

#### **Collective Worship in community schools**

SACRE has published Guidance to Schools on Collective Worship, to support schools in their statutory responsibility to deliver daily acts of Collective Worship. Cumbria SACRE also provides a section on Collective Worship for community schools as part of school governor training. Cumbria SACRE has been involved in talking to schools about a Collective Worship project being proposed by the University of Cumbria.

## Determinations - To allow any exception to the law that Collective Worship be broadly or mainly Christian

SACRE has received no requests for a determination for exemption from the law.

SACRE hears any complaints brought to the LA about RE and collective worship. No complaints from parents were received this year.

#### 4. A section on links with other bodies

SACRE has continued to develop strong links with Cumbria Development Education Centre (CDEC) and Culham St Gabriel's Trust.

Cumbria SACRE has continued to develop links with Humanist UK. The Humanist member has provided advice for their new funding bid for school work and has been asked to be a key presenter at the SACRE reps CPD session in March 2023.

# 5. A section on other areas of SACRE involvement locally Virtual Voices in Religious Education (VVRE) project

2021-2022 has been the main year of the VVRE Project – a collaboration between Cumbria SACRE and Cumbria Development Education Centre (CDEC) funded by Culham St Gabriel's Trust. During the autumn term, the project gathered of a group of volunteer 'voices' from across Cumbria to engage with students and teachers. The project team worked with the voices to support them to create their own personal 'worldview' film to share with schools as a preparation activity. During the spring and summer terms, a series of facilitated virtual events were held with a range of age ranges and schools. Events included:



The project has been showcased at several events, including: University of Cumbria RE ITT department (April 2022), The Culham St Gabriel's Showcase event (June 2022), North Cumbria RE secondary cluster group (May 2022), Cumbria SACRE Primary RE Conference (June 2022) with a presentation by pupils, headteacher and RE teacher from Asby Endowed School.

The events were recorded and edited as part of a digital resource which is available for schools across Cumbria. So far, over 30 schools have accessed the digital resources.





Plans for autumn 2022 include a sixth form event as part of Inter Faith Week, and a Diversity in non-religious worldviews event for KS2.
