1. Chair's Introduction, rationale, and context

Chair's introduction

I am pleased to introduce the SACRE Annual Report on behalf of Doncaster SACRE. The report reflects the different strands of work the SACRE has overseen in a changing educational scene, which continues to settle under structural and curriculum changes. The SACRE continues to provide advice and support to the wide variety of educational institutions and the Principal Authority on Religious Education and collective worship. The committee continues to monitor the uptake of religious education in as far as published information allows. Collectively we have responded to the DfE's letter regarding a review of statutory duties of SACRE and look forward to putting forward our views in due course. We continue to seek innovation in promoting interfaith work throughout the Borough to encourage mutual understanding in a world where sadly intolerance and conflict simmer. This is, to me as Chair, our strength and relevance.

Rationale

"SACREs have responsibility for advising a Local Authority (LA) on its schools.

For Religious Education (RE), SACRE advises community, voluntary, controlled and Trust and Foundation schools without a religious designation.

For Collective Worship SACRE advises the LA on community, Trust and Foundation schools without a religious designation.

SACRE's have a duty to publish an annual report. The main purpose of the annual report is to hold the LA to account, by informing the Secretary of State and key partners what advice SACRE gave the LA during the year and how that was responded to. This includes advice on RE and Collective Worship in those schools for which the LA has responsibility." (NASACRE – National Association of SACREs)

Context

Doncaster is a small LA with 17 secondary academies, one free school, almost a 100 primary schools (21 of these are now academies) and 5 special schools. Doncaster SACRE is keen to develop positive partnerships with all schools within SACRE's geographical area, including academies and free schools.

Information taken from the 2011 Census showed that 65.9% of people identified themselves as being Christian within the Doncaster Local Authority. The next largest faith group identified was Muslim at 1.7%. The other faith groups were identified as Sikh at 0.4%, Hindu at 0.3%, Buddhist at 0.2%, Jewish 0.0%, and people following other religions 0.3%. Doncaster figures mirror the national trend since 2001 of an increase in the number of people specifying that they hold no religious belief, a decrease in the number of people who profess to follow Christianity, and an increase in the numbers of people following other religions.

The 2013 Agreed Syllabus is an inclusive syllabus, recognising that whilst many pupils come from religious backgrounds, others may have no attachment to religious beliefs and practices. The syllabus provides a good range of opportunities for students to study Christianity, other faith traditions, and secular philosophies such as humanism. In this way, the religious education curriculum is broad and balanced, and all pupils have an opportunity to share their own beliefs, viewpoints and ideas.

All schools within SACRE's geographical area, including academies and free schools, are warmly invited to use the agreed syllabus and to access all the support services which promote high quality religious education and collective worship in Doncaster.

2. Advice to statutory bodies

Local Authority

SACRE has expressed concern about recent reports from the RE professional associations that government education policy has been detrimental to the provision and quality of RE at KS4, given that it is a statutory entitlement for every student. They asked the local authority what information they could provide to determine the extent to which this was a feature of the RE provision at KS4 in Doncaster.

The analysis of the 2015 KS4 examination results has provided some information about this. In addition, the RE Adviser resolved to analyse all Doncaster Academy Ofsted reports for the academic year 2014-15, as well as look at evidence about RE provision on the relevant academy websites to gain an additional insight. This would be reported to SACRE at the autumn 2015 meeting.

In the meantime, SACRE requested that the RE Adviser meet with the Portfolio Holder on the Council for Children, Young People and Schools (a SACRE representative) to explore the opportunities for discussing RE provision with the secondary academies and to offer support where appropriate. This meeting was scheduled for the autumn term 2015.

Schools

The SACRE area of the Doncaster Council website provides advice and support for teachers. The SACRE Annual Report 2012-13 and information for schools on the statutory requirement for Collective Worship have been added this year.

The RE Adviser produces an e newsletter each term to advise schools on behalf of the SACRE. The SACRE e- newsletter on RE and Collective Worship keeps school leaders, governors and RE teachers regularly informed about national and local developments which support the provision of quality RE and collective worship, including local faith contacts, new resources, practical teaching ideas, and CPD training opportunities. An archive of newsletters is featured on the SACRE section of the Doncaster Council website (Appendix 3)

SACRE has advised schools to actively participate in professional consultations to do with standards i.e. the proposals for reforming A level and GCSE Religious Studies.

SACRE requested that the RE Adviser create an up to date and comprehensive directory of local faith group contacts for the use of all schools in its geographical area. Schools have been provided with a web link to the Doncaster CVS Voluntary Sector Directory which has a comprehensive list of local faith contacts.

Government or other statutory bodies

Doncaster SACRE has written to Lord Nash, the Minister responsible for faith schools, in response to his letter dated 7th January 2015. They advised Lord Nash that they welcomed the proposal that the DfE intends to commission a review of SACRE annual reports – an important step in monitoring the work and effectiveness of SACREs and the support that SACREs receive from their Local Authorities.

The SACRE asked Lord Nash how the DfE proposed to hold local authorities to account where there were gaps in their support for SACREs, but more positively suggested that the DfE consider the practical level of support they provide for local authorities in fulfilling their statutory duties to their SACREs. SACRE indicated that they would appreciate further advice from the DfE on the nature of the relationship that it should have with Academies and Free Schools in the light of the Academies Commission Report 2013.

Finally, Doncaster SACRE added its voice to that of the National Association of Teachers of RE (NATRE) in calling upon the government to initiate an investigation into the level of provision for Religious Education at Key Stage 4 in England, and to take urgent action to ensure that students leave school with an appropriate level of religious literacy to equip them for life in a diverse modern society. Doncaster SACRE argued this needed urgent attention in the light of recent education policy which had impacted adversely on RE provision at Key Stage 4 in many schools and academies.

3. Standards and quality of provision of RE

Public examinations

The national picture from the Religious Education Council (REC):

The number of pupils in England and Wales taking GCSE Religious Studies full course has risen again this year, up 5.3% against 2014 to 283,756. This echoes the increase in A Level entries, which are up 6.5% this year compared with 2014.

However the removal of short courses from Department for Education (DfE) performance tables is having a serious and negative impact on the total number of pupils taking RS. The findings of the REC in 2015 continue to emphasise that government education policy in England is having an adverse effect on RE GCSE entries in England compared to Wales (where the EBacc and the average point score at GCSE have not been adopted as school performance measures).

The damage to take-up of the RS GCSE short course comes at a time when RS is otherwise a subject growing in popularity and when the government stresses the importance for young people to have knowledge and understanding of religions and non-religious beliefs. In addition, reforms to

GCSE RS make it an increasingly attractive and rigorous subject, while increasing numbers of pupils are carrying RS on to A-level.

The key outcomes for Religious Education in England and Wales at KS4 in 2015 are as follows:

There were 283,756 entries for the full course in GCSE RS, a rise of 5.3% from 2014 (269,494)

There were 86,679 entries for the short course in GCSE RS, a decline of 26.8% from 2014 (118,481)

There were 370,435 entries for GCSE RS (combined short and full courses), a decline of 4.5% from 2014 (387,915)

In 2014 there were 1,197 schools making no entries for any RS qualification; a rise from 268 in 2010.

29.6% of entries for the full course in GCSE RS were awarded an A or an A* 11.8% of entries for the short course in GCSE RS were awarded an A or an A*

In England GCSE RS short course entries have fallen from 211,269 in 2012 to 68,890 in 2015 (-67.3%). This is a dramatic decline over four years compared to Wales where GCSE RS short course entries have declined only slightly from 19,182 in 2012 to 17,789 in 2015 (-7.3%).

In England GCSE RS full course entries have increased from 216,182 in 2012 to 271,917 in 2015 (by 25.7%), compared to a lesser increase of 13.7% in Wales over the same period (from 10,409 in 2012 to 11,839 in 2015).

Overall, compared with 2012, 85,000 more pupils in England will complete key stage 4 without having gained a qualification in Religious Studies (a drop of 20.3%). The decline in take-up is a cause for concern, as echoed in research by the National Association of Teachers of RE (published in November 2013) that found that "a third of community schools and over a third of academies without a religious character are still failing to meet their legal or contractual agreements to provide religious education for this key age group."

On a much more positive note, the REC reported that entries nationally for A level RS are rising faster than for any other arts, humanities or social science subjects. "The contextual evidence shows the growing status of RS as a subject for Higher Education entry".

Doncaster GCSE entries 2015:

Short course entries have fallen dramatically. Entries in 2013 and 2014 remained relatively stable – 873 entries in both years, from 10 and 9 schools respectively. In 2015 only 383 students were entered from 7 schools, which means that entries have more than halved since 2014.

Full course entries are up by 46% on 2013 where GCSE RS full course entries in England have increased from 216,182 in 2012 to 271,917 in 2015 (by 25.7%).

Using RAISEonline, entry as a percentage of cohort for full GCSE is 32.3% compared to a national average of 45.1%. This compares to 26.5% and 42.7% in 2014 and 21.2% and 36.7% in 2013 for the same measures respectively.

Doncaster AS and A Level entries 2015:

Entries for the AS course increased slightly. The number of entries for the A Level course in the Doncaster local authority is up by 35% to 58.

Doncaster standards in public examinations 2015

For GCSE RS full course attainment in A*–C and A*–A measures has improved, with the gap to National figures narrowing.

At AS level the percentage of students achieving A*–E increased by 6.6 percentage points, but those achieving A or A* grades dropped by 3.5 percentage points on the previous year.

At A level, while the percentage of students passing the subject dropped slightly, the proportion of students achieving an A^*-C grade increased by nearly 15 percentage points and the proportion of students achieving an A or A^* increased by 4.4 percentage points.

Attainment in RE not covered by public examination

The attainment targets (as outlined in the 8-level scale) in the agreed syllabus provide a standards framework for teachers to use in their planning and target setting. Traditionally, Ofsted reports do not make reference to standards in RE in key stages 1-3.

Standards in primary schools and at Key Stage 3:

There is no LA strategy for collecting evidence on standards in primary schools or at Key Stage 3. Standards in schools for all subjects, including RE, are viewed by the LA as a matter for the leadership team in each school to monitor and to address.

LA professional development to support standards in RE in schools

The RE Adviser organised a number of professional development opportunities for all schools in the Doncaster area, including academies and free schools.

The RE Network event held at St George's Minster on 21 January 2015 proved to be a highly successful and productive event. One teacher reported: "Very interesting tour and guides. Lots of ideas to follow up. Will definitely make use of this fabulous resource on our doorstep" (Hexthorpe Primary)

The RE network event held at St Peter's in Chains RC church in June 2015 was similarly well received. The RE co-ordinator at Intake primary school said:

"Our visit to St. Peter in Chains was fascinating and inspirational. The chance to forge a link with such an amazing place and a knowledgeable and inspirational faith leader as found in Father Gus is an opportunity in a million. To also have the opportunity to network and share resources with like-minded colleagues is truly invaluable. Thank you so much."

At the Governor Forum in April 2015, the RE Adviser provided two workshop events on the importance of Spiritual, Moral, Social and Cultural Development (SMSCD). This drew upon the findings of the Schools with Soul Report from the RSA Action and Research Centre, and made links with the 2015 Ofsted Framework, Fundamental British Values, and evidence about SMSC in Doncaster schools taken from Ofsted reports sampled in 2013-4. Twenty six governors attended the training. The feedback from one parent governor whose school was inspected the week following the workshop was that it had been immensely useful.

The quality of RE provision in schools

No issues have been reported about the quality of RE provision in schools this year. Ofsted reports sampled have provided no evidence about the quality of RE provision. There is no LA strategy for collecting evidence about the quality of RE provision except through the monitoring of examination results. Quality assurance is devolved to the leadership team in each school to monitor and address (as is the case for the other subjects of the curriculum).

Withdrawal from RE

The RE adviser responded to one enquiry from a school about a parental request about withdrawing a pupil from RE (and the daily act of collective worship). As part of the advice about withdrawal from RE the school was directed to the relevant sections of the 2013 Agreed Syllabus and the Guidance Material document which accompanies the syllabus. This includes a checklist about managing the right of withdrawal. As part of the advice on withdrawal from Collective Worship the school was referred to the relevant sections of Circular 1/94. These documents can be found on the SACRE section of the Doncaster Council website.

Complaints about RE: compliance and time allocation for RE

Considering the demands of the Local Agreed Syllabus, the Agreed Syllabus Conference strongly recommends that schools dedicate a minimum of 5% curriculum time for the teaching of clearly identifiable RE.

It is difficult to monitor compliance in statutory RE provision except through complaints. SACRE has received no formal complaints about compliance in community schools this year.

However, the analysis of Ofsted reports for five secondary academies inspected in 2014-15 formally identified one concern with regards to the statutory duty to provide RE for every student, according to academy funding agreements. In one secondary academy, Ofsted described non-compliance in

RE at Key Stage 4, but did not highlight the significance of this and did not make it an action point for the academy.

"Students report that they do learn about other cultures and religions, but it is mainly restricted to their learning in religious studies, which some students do not study after Year 9" (Ofsted Report May 2015)

The SACRE discussed the quality of Ofsted inspections in relation to statutory compliance for Religious Education provision. Concerns were raised about whether inspections were looking in depth into compliance and what actions were taken where gaps were identified.

An analysis of the websites of the same academies (to try to gather information about the RE provision described in their curriculums) also indicated possible difficulties in provision and compliance. It is however difficult to get an accurate picture of compliance issues from this sort of snapshot information.

The issue of SACRE's relationship with academies was raised again at the 2015 NASACRE AGM. In addition, given the responsibilities that local authorities have for children and young people – which places local authorities as advocates for a broad and balanced curriculum, including RE, which is the only curriculum responsibility that local authorities have – what should an LA be doing to support academies with their statutory responsibility for RE? Greater acknowledgement of the complexity of these arrangements by the DfE would be appreciated, and also the difficulties and challenges these bring with them.

4. Agreed Syllabus

The 2013 Doncaster Agreed Syllabus is located on the SACRE section of the Doncaster Council website, together with a separate Guidance Material document to support subject managers and class teachers in their use of the syllabus.

The process for review of the 2013 Agreed Syllabus is due to commence in September 2016 if a new syllabus is to be launched by September 2018. Past experience has demonstrated that at least one year needs to be allocated to consultation, review and writing, and one year needs to be allocated to bringing the reviewed syllabus to publication, to plan a launch event, and to prepare and deliver training (introduce, embed, consolidate) for teachers.

An Agreed Syllabus Conference therefore needs to be planned for the academic year 2016-17.

The RE Review Report 2013 published by the Religious Education Council produced a new non-statutory curriculum framework for RE in England which is in line with developments in the revised National Curriculum. The future review of the agreed syllabus should take account of this new framework, and

in the meantime Doncaster SACRE will monitor closely how other LAs use this document in their syllabus development.

5. Collective Worship

Compliance with the statutory requirement

Community schools (and academies and free schools in accordance with their funding agreements, trust deeds or charters) have a legal duty to provide a daily act of collective worship for all pupils not withdrawn by their parents.

The revised 2013 Agreed Syllabus makes specific reference to the intrinsic value of collective worship, but reinforces the statutory distinction between it and RE, and the time that should be set aside for both:

"RE and collective worship both contribute to the spiritual, moral, social and cultural development of pupils in their distinctive ways. However, the curriculum time allocation for RE does not include time set aside for daily collective worship, which is a separate school activity".

Of the Ofsted inspections reports sampled this year, none have indicated a failure to comply with the statutory requirements for Collective Worship.

Quality of Collective Worship

To support schools in developing the quality of their collective worship provision and practice, SACRE provides advice and guidance through the SACRE e newsletters. The spring 2015 e newsletter included information and advice about the excellent service provided by the Open the Book volunteer teams. They organise themed and dramatized storytelling of Bible stories at no charge to primary schools. Using drama, mime, props, costume – and even the children and staff themselves – they present Bible stories in lively and informative ways

In addition schools were also informed about the RE Team who provide assemblies as well as RE lessons and Godly Play. They currently work in several schools in Doncaster.

No issues have been reported about the quality of collective worship provision in schools this year. The Ofsted reports sampled have provided no evidence about this. There is no LA strategy for collecting evidence about the quality of collective worship provision. Quality assurance is devolved to the leadership team in each school to monitor and address.

Determinations

SACRE has a statutory role in considering and granting determinations. Determinations are made when a school, on behalf of a number of parents, requests Collective Worship other than that set down in statute i.e. of a wholly or mainly broadly Christian character, though not distinctive of any particular Christian denomination.

There have been no applications for determinations in Collective Worship this year.

Complaints about collective worship

There have been no formal complaints about Collective Worship this year.

6. Management of SACRE

Membership (Appendix 1)

SACRE strives for a broad membership base in line with legal requirements. The SACRE Constitution specifies that the SACRE review the composition and attendance of each committee annually (at the beginning of each academic year).

There are two vacancies to fill on Committee A. Representation on Committee B has been halved so numbers need to be strengthened.

Representation and attendance on Committee C continues to be a cause for concern. The traditional route of recruiting new representatives through the teacher unions has not yielded results. The LA has therefore adopted a different strategy of sending a letter direct to schools encouraging expressions of interest. Initially at least there was a small response from four teachers (including teachers from academies). However, due to school commitments only one of these teachers has managed to attend at one SACRE meeting. Teachers say that gaining release time during the school day is an issue. It is hoped that a revised start time for future SACRE meetings next year (4.30pm) will improve attendance from members of Committee C.

Attendance at SACRE (Appendix 2)

The full SACRE has met on three occasions at The Mary Woollett Centre in Doncaster.

Dates: 24th November 2014 24th March 2015 29th June 2015

All meetings have been quorate, but sometimes only because of the presence of the RE Adviser who is also an NUT representative on Committee C. The annual review of attendance 2014-15 highlighted the need to follow up and clarify the position of those members who had not been able to attend any meetings during the academic year.

Training for SACRE

New members to SACRE are supported by materials produced by NASACRE: "So you're joining your local SACRE" - a handbook for SACRE members. Two local publications, the Doncaster SACRE Code of Conduct and the Doncaster SACRE Constitution, provide new members with appropriate advice about the context of their new role.

The SACRE consultant has been in attendance at every meeting this year to update members on national and local developments in RE and the wider curriculum as applicable. SACRE members are provided with an analysis of the annual Religious Studies examination results by a senior LA officer.

The LA ensures that SACRE members receive the regular Briefing mailings from NASACRE. Members are provided with the username and password required to access the e-version of the mailings in detail. They keep members informed about RE developments and provide a basis for agenda setting, discussion and action at SACRE meetings.

SACRE Self-Evaluation: this process identified three action points: To arrange to periodically rotate the nomination to the Chair across the four committees

To develop strategies for engaging with academies – beginning with encouraging representation at SACRE meetings To establish links between the SACRE and the Youth Council

Administration of and professional support for SACRE

SACRE is a statutory body that meets in public. Its meetings are part of the public record. The LA provides funding for SACRE from the Children and Young People's Services' budget for:

- a dedicated Clerk to support the Standing Advisory Council on Religious Education
- dedicated support and advice from the SACRE adviser
- essential administration costs

7. SACRE's contribution to the wider Local Authority agenda

Identify what SACRE has contributed to other agendas / the LA's public sector equality duty

Doncaster SACRE is committed to promoting and supporting high quality religious education and collective worship. To this end, it aims to develop a positive working relationship with all schools in its geographical area, including academies and free schools, and to encourage teachers of RE to collaborate and work in partnership.

Members from Doncaster SACRE have been involved in supporting EMTAS (the Ethnic, Minority Traveller Achievement Service) in developing a LA Cultural Awareness Booklet. The key areas of enquiry included Communication, School Admissions, Attendance, Equalities/Inclusion/SMSC, Parental/Community Involvement, Collective Worship, Dress Standards, Dietary Requirements, Curriculum and School Events.

The RE Adviser attended the CTSY (Churches Together across South Yorkshire) AGM at St Peters in Chains RC Church on 25 April 2015, and updated the SACRE on the events of this meeting.

The SACRE member representing Doncaster Interfaith provided a very interesting presentation on his involvement with students in Refugee Week. This inspired a discussion about the possibility of a similar educational event sponsored by SACRE in the future.

The Chair of SACRE agreed to contact the Youth Council to see if they would be interested in developing links with SACRE.

SACRE continues to have established links with the wider RE community such as NASACRE (the National Association of SACREs), AREIAC and RE Today services. The SACRE consultant is a member of AREIAC (the Association of RE advisers, inspectors and consultants). This year members responded to the 2014 NASACRE survey questions as a group. The RE Adviser submitted the responses to NASACRE on their behalf. In addition, a representative from Doncaster SACRE attended the NASACRE AGM on the 21st May 2015, providing a detailed report of the day to the SACRE.

On behalf of Doncaster SACRE the member representing the Balby (Doncaster) Society of Friends submitted a detailed proposal for a Westhill / NASACRE Project Award (based on the idea of developing a Doncaster Heritage Trail of religious places of interest). Although on this occasion the submission was unsuccessful, the idea has such merits that the SACRE received encouragement to re-work the proposal for a future application.

What SACRE has done to support schools through events and training

The RE Adviser co-ordinated the arrangements for the SACRE endorsement of and LA support for, the South Yorkshire RE Professional Development Day held on the 29th January 2015 in Rotherham. The Better RE Conference focused on providing practical inspiration for spiritual, moral, social and cultural development through RE. It was a conference endorsed by four SACREs - Doncaster, Rotherham, Sheffield and Bradford. Twenty six Doncaster teachers signed up for this conference.

Feedback from the day was overwhelmingly positive - 90% of teachers rated it excellent. It focused on creativity, thoughtfulness, values and achievement in RE, with plenty of practical activities for teachers to take back to schools. As a result, Doncaster SACRE has agreed to endorse and support a second conference entitled "Inspiring RE" planned for 4th March 2016, and the LA has once again agreed to use its communication resources to advertise this to schools.

Doncaster SACRE has always promoted the merits of the Farmington Fellowship Award scheme at the Farmington Institute, Harris Manchester College, Oxford. The RE Adviser is a Farmington Fellow. This year a teacher

from a Doncaster secondary academy was awarded a Fellowship and has been invited to present their research at the 2015 autumn term SACRE meeting.

Links to broader community initiatives

The diversity of the SACRE membership ensures that there are appropriate channels of communication between the SACRE and the constituent faith and cultural groups in the local area. SACRE members have the opportunity to represent to SACRE the interests and concerns of their faith communities, and also keep their faith communities informed about the work of SACRE. Some SACRE members are also members of the College Chaplaincy Group, and other SACRE members are active members of the local Interfaith Group. Their knowledge and experience support the work of SACRE

The Agreed Syllabus reflects the diversity of faiths not only in the local area but nationally. It emphasises the importance of RE in promoting social, racial, and religious harmony and thus is an important local authority document promoting community cohesion.

8. Summary

SACRE is concerned about the potential dangers at KS4 of "the opening up of a statutory compliance gap, with fewer students getting their RE entitlements" (Lat Blaylock). It is concerned that in its report to a school or academy, Ofsted can describe non-compliance with regards to students' statutory entitlement to RE, but not highlight the significance of this or require a school to take action to remedy the situation.

With the dramatically changed educational landscape in the last few years, a key action point arising from this report is for the local authority to provide SACRE with a clear picture of the number of schools their advice applies to, and the number of pupils these schools educate (to be updated annually).

It has been a busy year for SACRE, with increasingly packed agendas to address. The enthusiasm of our SACRE representatives is to be commended.
