Dorothy Snowball resigned from the SACRE at the meeting held in February 2020, as she is retiring from work and will be pursuing other hobbies and activities. We thank her for her work with us and wish her very well for the future.

The principal topics discussed this year have included:

- Supporting local schools in their delivery of the locally agreed syllabus. [See Section 2]
- Communication with schools. [See Section 3]
- Review of the SACRE constitution [See Section 4]
- Self Review [see Section 6]
- Action Planning [see Section 7]

The outcomes of deliberations in these areas form the basis of this Report.

### 2.0 Supporting RE Teaching

SACRE sponsored an RE Conference for local teachers in November 2019. This was largely organised by Stephen Jones and we are grateful for his input. Forty-three delegates attended, and between them they represented all sectors and phases of local education. This is considered to be a good turnout for local conferences and the £500 surplus generated by the conference was earmarked to support RE Network meetings. Feedback from delegates was positive with thirty rating the conference 'extremely good' and ten rating it 'good'. The conference was opened by Sarah Clark, the newly appointed Bishop of Jarrow, and her talk went down very well indeed. One of the themes of the conference was on assessment in RE and in particular how to capture assessment in written work. Points which have been highlighted for future consideration include: high quality teaching resources for schools to use; an imbalance in this conference in religions supported, with a need for more on Buddhism and Sikhism; and the possibility of considering Ofsted's 'deep dives' in RE and how schools can be prepared for these. It is hoped that the conference will be an annual or bi-annual event – though Covid-19 has meant that no plans have been made to host another conference yet this year.

Two RE Network meetings were planned following the conference, one for April and one for June. However, these were cancelled due to 'Covid lockdown'. We hope these will run in 2020/21, albeit as virtual meetings.

We reviewed the websites of Gateshead's mainstream secondary schools and in particular what they said about the teaching of RE, and in the case of Academies compared this with relevant statements in their funding agreement. In March the SACRE Chair wrote to a number of local secondary schools whose websites did not make it clear enough to us that they were providing pupils with an appropriate RE curriculum. There were several responses and promises of further information which merit further exploration. However, this follow-up was not done during lockdown and is planned for next year.

A complaint by a member of the public to the DfE regarding the alleged inadequate teaching of RE at one of our local schools was investigated by the Local Authority and a report made to SACRE by the Education Service Head. The conclusion of the investigation was that the provision of RE in the school was not inadequate and no action was needed.

### 3.0 Communicating with Schools

Traditionally, the SACRE has communicated with schools through a variety of means, including a termly newsletter. This year, however, we have decided to change this. RE will be covered in an annual 'curriculum letter' from the LA to Primary Schools and by information about network sessions.

#### 4.0 Review of the SACRE Constitution

Work by the LA on reviewing the SACRE Constitution has been completed and we will now implement it. during [MGI] future mee

## 5.0 Examination Data Analysis 2019 outcomes – based on provisional data

Due to the Covid-19 pandemic and the subsequent cancellation of public examinations in the summer of 2020, there is no results-based accountability for schools this year. The DfE has decided not to release the teacher assessments which replaced examinations. We considered writing to schools to gather this information but decided against this, partly because the outcomes would not be comparable with

previous years so would be less meaningful and partly through a desire not to place an additional burden on schools during the pandemic.

#### 6.0 Self Assessment

Work to populate the virtual platform that Gateshead LA has offered to the SACRE is ongoing. More needs to be done to make best use of this.

The letters to Head Teachers of local secondary schools regarding RE provision need to be followed up, as appropriate to the responses received.

RE Network meetings have not taken place due to the effects of Covid-19 and these need to be established.

Now that the constitution has been reviewed, the cycle of reviewing committee membership should be re-instated.

#### 7.0 Action Plan for 2020-2021

This Action Plan focusses on supporting teachers, communications and on analysis of examination data.

Successful implementation will be reliant on the active engagement of SACRE members, the school community, and the School Improvement Team.

Monitoring will be a standing item at SACRE meetings.
