1. Introduction

a. Foreword

The year 2021-2022 has been a challenging one for schools, as they sought to catch up from lost learning due to the Covid-19 pandemic, and to make progress with their RE. SACRE has responded to some of these challenges through its review of the current agreed syllabus, which ran until summer 2022. There has never been a more important time for SACREs to be well informed and proactive in establishing an agreed syllabus that is both rigorous and relevant. The desire to produce a curriculum that is truly co-created, draws on the best educators' thoughts about high quality RE at the same time as responding to the county's context through engaging with faith communities in meaningful ways remains at the heart of what we have done over the year. In addition, SACRE is mindful of the time lost in working with the 2017-2022 syllabus, as well as the progress of the RE Council's 'worldviews project'. As a result, SACRE has extended the life of the current syllabus to 2025.

Listening to the voices of teachers (and indeed students) as well as providing high quality training and support has sharpened our focus and redoubled our efforts. To that end, we are hugely grateful to Stephen Pett for his leadership, sheer hard work on our behalf but above all for his wisdom. We are also delighted that Trevor Cooling has been able to join us. Indeed, my sincere thanks to all the members of SACRE for their support through this time.

On behalf of members of SACRE, I would also like to extend our good wishes to representatives who left SACRE either to move on to pastures new or to retire and to thank them for their work.

There is no doubt that SACRE will continue to provide a strong message about the importance of Religious Educations as our Agreed Syllabus Conference continues working to determine the very best opportunities for the children of Gloucestershire - we are looking forward to the challenges.

b. Overview of the work of SACRE

A Standing Advisory Council on Religious Education (SACRE) is a statutory body set up to advise the Local Authority on matters related to religious education and collective worship. Its members are drawn from teachers, Local Authority representatives including Councillors, faith representatives from the Church of England and a range of Christian denominations, and representatives from other religious groups represented in the region.

SACRE's key functions include monitoring the provision and quality of RE, and providing advice and support on the effective teaching of RE in accordance with the agreed syllabus. This includes advice on methods of teaching, choice of teaching material and provision of teacher training. This is primarily done through the review and implementation of the locally agreed syllabus, a process which is required every five years. This is followed by on-going monitoring of its effectiveness in the light of changing national education policy.

It is a legislative requirement that each SACRE produces an annual report of its work and that this is published, sent to the local authority, to NASACRE and to other interested parties such as the Department for Education.

During the academic year 2021-2022 the Chair of SACRE has met regularly with senior officers of the local authority to monitor and discuss future relationships and the work of SACRE. These have been productive meetings and have maintained the local authority's awareness and continuing commitment to fulfil its statutory role in supporting SACRE. With the retirement of the long-standing LA officer, Jane Lloyd Davies, Head of Education Performance and Intervention in August 2021, Ms Clare Dudman, Head of School Improvement, has taken over the role.

SACRE met on three occasions during the academic year 2021/22. The management and access to these meetings has been in line with all regulations.

Two of the three meetings in 2021-22 were quorate with members of each of the four constituent groups in attendance. The LA officer was unable to connect to the Zoom meeting on 19 Nov 2021 for technical reasons, which meant that that meeting was not quorate. 2. Religious Education

a. The locally agreed syllabus and RE in schools

The Gloucestershire agreed syllabus was launched in 2017, with over 180 primary schools attending launch training. Around 100 primary schools regularly attend annual SACRE conferences, with a focus on implementing the syllabus and developing teaching and learning. SACRE believes that most, if not all, primary academies are using the Gloucestershire agreed syllabus. Not all secondary academies are using it in full, although many use it to inform their practice.

The Agreed Syllabus Conference (ASC) was established in February 2021. One decision taken has been to extend the current 2017-2022 syllabus to 2024. One reason for this option was to take into account the challenge of the pandemic, with its impact on how much RE time has realistically been given during lockdowns and during catchup. A second reason is to allow for more progress in the REC's Worldviews Project (final report due May 2024), so that it can inform the review.

Schools will be consulted through surveys and during attendance at forthcoming conferences and hub meetings.

b. Standards and monitoring of RE

This is the first year since 2019 that GCSE and A level Religious Studies examinations results can be reviewed. Data on these results can be seen in Appendix 7c below. SACRE thanks teachers who have supported students and taught them in extremely difficult circumstances.

SACRE regularly reviews school workforce survey data when it is available, reviewing school websites and surveying schools to explore provision further.

OFSTED reports can also provide a way of monitoring RE. SACRE will be looking at examples of local OFSTED reports that comment on RE. The new OFSTED inspection framework and RE research review is bringing a renewed focus on RE in schools where RE was struggling to get sufficient curriculum time.

c. Teacher training and materials and advice for schools

Network meetings

The Diocese of Gloucester runs eight regional hub groups for primary schools, run by hub leaders who are supported with training by the Diocesan adviser, Debbie Helme. The groups meet termly and are attended by teachers from Church of England schools and community schools and academies. The Diocese runs its own annual art competition and has held public exhibitions of the winning art in the past.

SACRE primary RE conference, 27 May 2022

The annual primary RE conference took place in person at Puckrup Hall Hotel – a welcome return after cancellation in May 2020 and online in May 2021. 90 schools attended. .

Teacher evaluations included details of what they planned to do as a result of the conference, some requests for future training. After the first keynote, which explored the nature of worldviews and the outline of a worldviews approach, teachers gave detailed feedback on their response to the approach underpinning the review of the agreed syllabus.

SACRE secondary RE conference, 25 June 2021

Gloucestershire SACRE collaborates with Herefordshire and Worcestershire SACREs in putting on a secondary conference each year. This year it was in-person after the online event in 2022. 13 delegates attended from the three counties.

3. Collective worship

a. Standards and monitoring of Collective Worship

SACRE has found it hard to monitor collective worship over the past few years. It is noted that schools found different ways of delivering Collective worship virtually during the last difficult year.

b. Determinations

No determinations have been requested in the year 2021-22.

c. Teacher training provided

No SACRE training on collective worship has been provided in 2021-22, although the Diocese of Gloucester continues to support its schools in this area.

d. Other information

There were no formal complaints to SACRE about collective worship during the year.

e. Advice to the Local Authority

No advice was given to the local authority around the provision of collective worship.

4. Links with other bodies

a. National Bodies

- Gloucestershire SACRE is a member of NASACRE. Its newsletters are circulated to all members. Stephen
 Pett, adviser to SACRE, and Professor Trevor Cooling, Committee B, presented a workshop on the
 Worldviews Project to NASACRE members in February 2022.
- Stephen Pett, RE Today, connects SACRE with NATRE, and provides national updates at each meeting.
 Reports from NATRE, including the School Workforce Data and regular primary and secondary surveys
 have proved useful to SACRE when monitoring schools. Further resources, such as those for home
 learning, from NATRE have been shared with schools.
- Information from the RE Council has been used in meetings and shared with schools where appropriate.
- The REC Worldviews Project draft resource offering guidance on a Religion and Worldviews approach (May 2022) has been a helpful resource for discussion for SACRE.

b. Local bodies

Gloucestershire Diocese provides excellent support to SACRE.

Members often attend NASACRE CPD and the Southwest SACRE conference, reporting back to members.
