### Part one

# The establishment, terms of reference and meetings of the SACRE

- 1. The Borough's SACRE was established by the Education Committee in January 1990. Its current terms of reference, as laid down by the Education Reform Act 1998, are: "to advise the authority upon such matters connected with religious worship in county schools and the religious education to be given in accordance with an agreed syllabus as the authority may refer to the Council or as the council may see fit."
- 2. In particular the SACRE is charged with the following responsibilities:
  - It can require the authority to review the Agreed Syllabus on religious education.
  - It may determine, on application by the headteacher that the requirement for collective worship in community schools to be wholly or mainly of a broadly Christian character shall not apply to the collective worship provided for some or all of its pupils in a particular school.
  - With the authority, to review the support offered for RE teaching, the methods of teaching employed, and teachers' in-service professional development.
- 3. The SACRE met on three occasions in 2016 to 2017:
  - 7 November 2016;
  - 2 March 2017;
  - 22 June 2017.

- 4 The SACRE usually meets at the Lilla Huset Professional Development Centre, 191 Talgarth Road, W6 8BJ. Secretarial assistance and a budget for the discharge of its duties is provided to SACRE by the Borough. The SACRE is grateful to the Borough for making this support available.
- 5. The Summer term meeting of the SACRE took place at Melcombe Primary School W6 9ER. The meeting was hosted by Liberty Sandeman a teacher at the school and a member of the SACRE. The meeting included a tour of the school

### Part two

# Matters dealt with by the SACRE in 2016 to 2017

- 1. An on-going issue for the SACRE has been membership numbers. However, there are constant efforts made to increase membership. Information on the SACRE is keep up to date on school zone, so that individuals interested in joining can make contact with the clerk to the SACRE. Regular contact is made with the appropriate appointing bodies to remind them when members are required. Also every SACRE communication sent to schools provide information on the SACRE and they ask anyone interested in membership or finding out more information on the work of the SACRE to contact the Clerk directly.
- 2. There has however been a constant membership of the SACRE maintained but unfortunately only one of the three SACRE meetings held was quorate. The SACRE welcomed a new member this year - Liberty Sandeman a teacher at Melcombe Primary School. It was with sadness that the SACRE bade farewell to Zelda Bailey a long standing member and a Humanist representative of the SACRE. She left to return home to Australia.
- 3. Matters discussed during the year include -
  - New NASACRE constitution
  - Ramadan guidance
  - RE Council Independent on RE
  - Freedom of Information Request (one request made this year)
  - Westhill Grant Bid.
- 4. **Ramadan Guidance** Guidance is provided by Naif Sheikh (SACRE Muslim representative) the guidelines were sent out to schools in the Borough.

- 5. Westhill Bid – a working party of the SACRE met to develop a bid around creating a Collective Worship Handbook The aim being to create an online handbook, easily accessible by all Primary Teachers, which includes two strands. The first strand would give up to date guidelines about expectations, legal requirements and policies. Within the second strand, the aim is to offer a variety of examples of good practice, each demonstrating how to celebrate 'collective worship' in a diverse fashion. This should help schools to meet the requirements for daily collective worship in a creative and constructive way. Also, it would give ideas for teaching through dance, music, room layout and ideas for topics or themes. The bid was costed and had been for £4,000. However, the bid was unsuccessful. The SACRE will look at the feedback received from the organisation and will look at the feasibility of submitting a new bid in the future.
  - 6. Lesley Prior keeps members up to date on RE matters. She reported on the RE Local Co-ordinators meetings.
    Liberty Sandeman stated that she had found it useful to meet items covered included prayers and assemblies. It had been a small first meeting but a wide range of subjects had been covered. It was noted that future items would include Assessment and Collective.

#### The requirement for Collective Worship

7. The SACRE received no requests in 2016 to 2017 from headteachers seeking a determination to lift or modify the requirements for collective worship in their schools. The procedures for making such a request are set out in Appendix A of this report. Information about the procedures can also be obtained from the Clerk to the SACRE at the Town Hall, Hornton Street, London W8 7NX.

#### **Complaints**

8. The SACRE was not in 2016 to 2017 asked to deal with any complaints about the RE curriculum or about religious worship in community schools.

# **Appendix A**

# The requirement for Collective Worship

#### Introduction

- Section 7 of the Education Reform Act 1988 lays down that the collective worship required in community schools shall be wholly or mainly of a broadly Christian character. DES circular 3/89 states that, in the Secretary of State's view, an act of worship which is 'broadly Christian' need not contain only Christian material provided, taken as a whole, it reflects the traditions of Christian belief. Any such worship should not be distinctive of any particular Christian denomination. It is not necessary for every act of worship to be of this character but within each school term the majority of acts must be so.
- 2. How collective worship is organised is for the headteacher to decide after consultation with the governing body, having regard to the following considerations:
  - any relevant circumstances relating to the pupils family backgrounds, for example the faith of the family;
  - their ages and aptitudes.
- 3. These considerations should inform:
  - the extent to which (if at all) any acts of collective worship in the school are not of a broadly Christian character;
  - the extent to which the broad traditions of Christian belief are reflected in those acts of worship of a broadly Christian character; and

 the ways in which those traditions are reflected.

#### The role of the SACRE

- If the headteacher of a community 4. school considers that the requirements for collective worship described in paragraph two could conflict with what is required by paragraph three, he or she can apply to the local Standing Religious Advisory Council on Education (SACRE) to lift or modify the requirements. Before doing so the headteacher must consult the school's governing body who in turn may wish to seek the views of parents. The headteacher's application does not need to apply to the whole school. It can be limited to any class description of pupils at the school, and might relate, for example, particular group or year group(s) in the school in which there were many pupils of a particular faith or religion.
- The purpose of this procedure is to 5. allow for acts of collective worship according to a faith or religion other than Christianity where, for some or all of the pupils in a school, requirement that worship should be of a broadly Christian character inappropriate. One factor which may inform a headteacher's decision to make an application to the SACRE is the extent of withdrawals from Christian collective worship.
- 6. In considering whether to grant a headteacher's request, the SACRE must take account of any relevant circumstances relating to the family backgrounds of the pupils concerned. When it has made a **determination** on the request which can only take the form of acceptance or rejection without modification it must communicate this in writing to the headteacher and state

the date from which it will take effect. It is for the headteacher to decide what form the alternative worship will take, although the SACRE should be informed of the proposed arrangements.

- 7. The headteacher will wish to take appropriate steps to notify governing body and parents of the new arrangements. Where such determination is made in respect of all or some of the pupils in the school, daily collective worship must still be provided for them. Where determination has been granted in respect of a class or description of pupils of a particular faith or religion, the alternative collective worship may be provided for those pupils as a whole. It may not be distinctive of any particular denomination of any faith or religion, but may be distinctive of a particular faith or religion. Parents continue to have a right to withdraw their children from this collective worship.
- 8. Any determination made under these arrangements ends after five years, unless renewed by the SACRE. There must be a review by the SACRE no later than five years after any determination was introduced; and subsequently within five years of each review. The headteacher can request an earlier review at any time, after consulting with the governing body. The headteacher must be given an

- opportunity to take part in any review and, in turn, is required to consult the governing body who may wish to seek the view of parents.
- 9. It has been a legal requirement since 1944 that all pupils attending a maintained school should take part in daily collective worship. Section 6 of the Education Reform Act provides for flexibility in timing and organisation of daily collective worship. It need now no longer be held at the start of the school day. There may be a single act of worship for all pupils or separate acts for pupils in different age groups or school groups. For this purpose, a 'school group' means any group or combination of groups in which pupils are taught or take place in other school activities; it does not mean a group reflecting particular religious beliefs.
  - 10 If a headteacher considers that changes of the sort described in paragraphs four and five of this appendix are justified, he or she should:
    - consult with the governing body,
    - after that, make application to SACRE on the attached form.
