Hampshire has continued to maintain a reputation for high quality RE in its schools. The concept-led, enquiry approach enriched by the development of skills of philosophical enquiry, as required by the locally Agreed Syllabus, has provided rigour to the subject which continues to be recognised locally and nationally. Interest continues to be expressed by other local authorities. Members of neighbouring SACRES have attended new SACRE members training run by Hampshire Inspector/Advisers and which related directly to Living Difference Revised 2011.

A particular strength of the subject is the number of teachers trained on SAPERE accredited courses in philosophical enquiry in Hampshire schools which continues to rise. Practice is embedded into the planning of work with Living Difference Revised 2011 and contributing to the raising of attainment in RE in a growing number of schools. Head teachers, especially in secondary schools, recognise the contribution it can make to teachers' higher order questioning skills and students complex thinking and writing in RE. A further significant strength for RE in Hampshire is the level of support offered to schools through the inspection and advisory service (HIAS). Hampshire continues to have two RE inspectors although both are part time for RE. However, sadly we have lost the services of our Advanced Skills Teachers during this year due to government changes in funding. SACRE monitoring visits to both primary and secondary schools continue to reveal that, where support from the Senior leadership team for RE is strong, RE thrives.

What are the main weaknesses and development needs of RE in your local authority?

Transition between KS2 and KS3 continues to be in need of improvement.

In some places there continues to be a need for on-going development of senior members of staff to enable them to understand and support Religious Education in their schools.

Evidence from SACRE monitoring visits, RE Inspector/Advisor visits, courses and RE development groups indicate that a high proportion of schools are compliant with the requirements of the Agreed Syllabus.

In the primary phase time allocation to RE is good and it is effectively integrated with other areas of the curriculum in a number of schools although this is not sufficiently embedded in all schools. In the secondary phase time allocation for all pupils at KS3 is in general good. Time allocation to RE at Key Stage 4 is generally good with most young people having the opportunity to access a GCSE qualification (either short or full course). These courses are recommended to be taught by specialist teachers. This is usually but not always the case. Some schools are offering an alternative non-examination course to all students. There are some examples of outstanding practice with such courses. It remains a concern however that students in a very few schools are not able to access their entitlement to Religious Education at KS4.

There is only limited evidence that the introduction of the EBacc measure is having any impact on the provision and compliance of RE at KS4. Where the leadership of a school value the contribution of RE, compliance and provision at KS4 is unaffected by the EBacc.

Full course:

The residual analysis reveals the performance of pupils in RS compared to other subjects. 77.3% of all students achieved A*-C grade. This is the best A*-C result on record.

This year we have seen an important upward shift in both boys' and girls' achievement in Full Course RS. For the first time, residual analysis reveals that in Hampshire in 2012, both boys and girls achieved better in RS than in their other full course subjects. This is not the case nationally where boys are still seen to achieve less well in RS than in their other subjects. Hampshire is now bucking the trend with boys' achievement in RS. Boys' achievement has been better that girls' against the national picture. This has been a targeted area of concern and these results give early indication of possible impact of intervention. Short course:

Residual analysis indicates that within Hampshire, boys continue to perform less well than the girls for RE than they do in their other subjects. This may be due to less time allocation to teaching RE in the short course and also it is sometimes taught by non-specialists. However, nationally the findings indicate an even further drop in performance. As a result, in comparison, Hampshire figures indicate a more positive picture than the national picture.

In general, time allocation for RE in Hampshire at KS3 is good; however, not all students have access to a specialist teacher. Access to specialist teaching at KS3 is especially important at KS3. High quality training is available for RE NQT's in county and this enables all NQT's who begin teaching RE in Hampshire Schools to become expert practitioners with County Agreed Syllabus 'Living Difference Revised 2011' by the end of their first year. For teachers appointed to Hampshire posts from out of the county, the county Network groups have been available to develop practice according to the Agreed Syllabus. A new course 'Getting to grips with the Agreed Syllabus at KS3 and 4' has been run successfully for non-specialist teachers or teachers who trained out of the county at the RE Centre.

There is evidence now that several GCSE specifications are highly suited to teaching with the cycle of enquiry as in the Agreed Syllabus 'Living Difference Revised 2011'. Where this has been supported by higher order questioning there are indications that standards rise at KS4. The Agreed Syllabus methodology can raise challenge and develop teacher questioning skills. Where teachers learn to nudge students to think in more complex ways, students' capacity to inter-relate concepts for example, is enhanced. Furthermore, aspiration and attainment has been seen to rise.

Some support from HIAS inspectors has been taken up by special schools this year. However the development group for specials schools has not taken place due to poor uptake. Adaptation of the enquiry approach as in Living Difference Revised 2011 has been shown to benefit pupils who have a wide variety of different needs and material for teachers remains on RE page of the Hampshire Website.

RE managers continue to be supported by senior management in primary phase schools in terms of professional development, attending courses and development groups and seeking support and advice from the inspection/advisory team. A wide variety of courses has been offered and uptake has been good. Financial support for professional	
development for RE has been maintained over the past year. A particular weakness of the subject continues to be the lack of continuity of responsibility for managing RE in primary phase schools. In many schools the appointment to the role of RE Manager may only be for one or two years which results in a lack of growing development in subject expertise available in a school.

Training for Heads of Department is available to schools. This is through a regional structure of RE network meetings as well as a well- attended Annual Leadership conference. Targeted training for new Heads of Department has also been offered. An important factor which hampers RE thriving is low level recognition and support from senior leaders

Key area 1f: Teacher recruitment and retention, level of specialist provision

The County Inspector/Adviser keeps in good contact with providers of new specialist RE teachers. A Post Graduate Certificate of Education course has run in all three of the initial teacher training institutions in close proximity to Hampshire - Chichester, Winchester and Southampton, albeit with some reduction in numbers. Teachers who train in these institutes in general are appointed as newly gualified teachers into secondary RE departments in Hampshire and already experienced the Hampshire Agreed Syllabus 'Living Difference Revised 2011'. The County Inspector has been commissioned to teach regularly on the Winchester PGCE course during 2012/13. Schools continue to be advised to advertise vacancies on the Hampshire website, Hantsweb. The County Inspector continues to develop contacts with initial teacher education institutes further afield for example at Oxford University Department of Education, Bristol University and the Institute of Education in London. Contacts are being made with the new teaching schools and those offering 'Schools' Direct' courses in Hampshire but so far no RE teachers have been trained this way.

Hampshire schools recruited 7 NQT (newly qualified teacher) RE specialists in 2008-9. In 2009-10 there were 16 NQTs in Hampshire schools; in 2010-11 12 and in 2011-12 8 in 2012/13 also 8. Contact continues with teachers who remain in Hampshire departments and continuing professional development (CPD) opportunities are offered to ensure there is clear progression of professional development for RE teachers in Hampshire. Overall at the moment specialist provision in Hampshire remains at a good level.

Budget allocation to RE in primary phase schools is variable. Some schools allocate an annual income to support the development of RE but others provide no financial support unless the subject has been identified on the school development plan as a priority for development. Access to ICT (information and communication technology) in primary phase schools is generally good, but the opportunity to use ICT for RE development is less well-utilised other than regular use of the interactive whiteboard.

Budgeting allocations for RE seem to be remaining constant, however this is not consistent across the county as schools have widely varying strategies for distributing resources. ICT access is good and teachers are in general confident with this. VLEs (Virtual Learning Environments) are continued to enable new innovations in learning both inside and outside the classroom.

The County RE ICT learning platform (Moodle) (<u>http://hias.gov.uk/re</u>) continues to be an effective means of disseminating good practice and information on courses, events and new initiatives in relation to the Agreed Syllabus and national developments. It provides more interactive opportunities for teachers to share and communicate issues in relation to RE teaching and learning. This has continued to be developed over the past year to include a wider range of resources to share, recommended activities and samples of pupils' work.

The County RE Centre has continued to support the work of teachers across Hampshire. During the academic year 2012 - 13 there were 390 subscribers to the Centre including some schools from other local authorities. It is used by RE teachers including PGCE (Post Graduate Certificate in Education) students for viewing and loaning resources, as a meeting place for planning, consultations and training and as a source for inspiration and information. It is now housed in the same building as the County History Centre providing a more streamlined service to schools and opportunity for wider dissemination of information between the different users of the centres.

The administration officer/RE Centre manager has continued to assist in the production of teaching packs (CDs and accompanying booklets), which provide guidance and materials for the development of RE units of work to support the delivery of the Agreed Syllabus for RE. These are purchased through the RE Centre and have proved to be very popular with schools. She has continued to develop and market a wider range of artefact boxes which are loaned to schools resulting in a continued increase to the RE Centre's income and, as a result, further investment in resources.

A comprehensive programme was carried out during the year to support NQTs (Newly Qualified Teachers) in both primary and secondary schools. New teachers were introduced to the requirements of the Agreed Syllabus and provided with support for effective teaching of RE in Hampshire schools. County Steering and Development groups have been in place for 9 years, meeting termly for CPD (continued professional development).

A comprehensive programme of courses has been provided over the year (See Appendix 2) for the continued professional development of teachers.

Evaluations from teachers who have attended courses and development groups indicate that they are enthusiastic about the approach of the Agreed Syllabus.

Feedback from the qualitative and quantitative 'Survey Monkey' research undertaken this year, shows that compared to a similar study 5 years ago teachers are feeling more confident about ensuring progression and embedding assessment into their practice. Head teachers also indicate in the feedback from visits that the support offered to schools is highly valued. SACRE monitoring visits indicate that standards in RE improve as a result of all these things working together over time.

Primary RE Development groups have continued to run successfully. During the academic year 2012-13, more than 30 primary RE managers attended one of the 3 regional groups, provided each term led by the RE Inspector, to share and develop good practice in RE in their schools. A primary steering group also meets each term and develops support materials and guidance which is disseminated on the county RE website or through publications available from the RE Centre.		
40 secondary teachers, including County Steering Group members, attended the secondary RE Leadership Conference in October led by the County RE Inspector in October 2012. The power point presentations used were put onto the RE Moodle accessible by those who attended the course. The regional network groups meet in Winchester and Basingstoke. A Secondary Steering Group meets once each term. The County Secondary AST's for RE met until Easter when the AST programme ceased to receive government funding. The County Inspector/Adviser now works alone. Three new small courses ran in the RE Centre: 'Getting to Grips with The Agreed Syllabus' was a half day course for non-specialists wanting to understand how to work with the Agreed Syllabus; 'Planning a Unit on Islam' was another successful half day course; 'Leading your Department to Outstanding' was a successful full day course for good department leaders. The special schools' group has not met this year.

Hampshire SACRE, with its partner authorities Southampton and Portsmouth are monitoring the impact of the Agreed Syllabus. Joint SACRE meetings have been taking place once each term for the past year. Here opportunities and hurdles to effective implementation are discussed.

The programme of development groups and courses, conferences and staff training in schools reflects the requirements of the revised Agreed Syllabus and are being offered systematically to Portsmouth and Southampton Schools.

The Hampshire Agreed Syllabus will be due for review in 2015/16.

The conceptual enquiry approach of the Hampshire syllabus, Living Difference, was initially well-supported by QCDA and OFSTED. Living Difference Revised 2011 includes QCDA's recommended "Fields of Enquiry" and takes into account elements of the Non-statutory National Framework such as "breadth of study". However, it contains one attainment target and an eight-level scale corresponding to progression envisaged in the Agreed Syllabus.

SACRE's five year development plan (see Appendix 3) addresses the implementation of the revised Agreed Syllabus through a continued pattern of courses and development groups, regular publications of newsletters, resource packs and the RE website and virtual learning platform (Moodle).

Two 'Living Difference' Handbooks (one primary and one secondary) were published in 2006/7 to support the implementation of the Agreed Syllabus. These publications contain comprehensive advice on planning, delivery, assessment and self-evaluation, and comprehensive examples of units of work with accompanying resources. These continue to be very well received in Hampshire, Portsmouth and Southampton and continue to provide support for the revised Agreed Syllabus. There have also been requests for copies from teachers and RE advisers in other authorities. Elements have been revised, including the secondary planning tool which has been further redeveloped in light of the new Ofsted framework which came into effect in 2012.

This brought to teachers' attention the importance of being aware of the indigenous traditions religious beliefs and how contemporary culture has several ways to undermine this. New cycles are in the process of being produced as a result of this.
