

#### 1. (1a) Chair's Introduction

As the Chair of the Haringey Standing Advisory Council on Religious Education (SACRE), it is my pleasure to present this report on the work done by the SACRE in 2023-24. The work carried out during the year that is outlined in the report reflects the care and attention shown by Jan McGuire, our Religious Education Adviser, who has provided an invaluable steer for the Council, and Fay Jackson, acting for the Haringey Education Partnership (HEP) and the local authority, who helped ensure the efficient conduct of SACRE and oversaw the implementation of decisions. I would like to thank all the other Council members who have given their time and attention to the SACRE in the past year – faith representatives, teachers and local authority councillors. I am especially grateful to Glenford Johnson, the Vice-Chair of SACRE, for chairing a meeting in my absence. The able clerking support provided by our new Clerk, Christine Hatt, was greatly appreciated. In the course of the year the SACRE bid grateful farewell to Rev. Bob Allaway, retired Baptist minister (and my predecessor as SACRE chair), Ali Arslan, representing the Alevi community, Sandra Kviat and Judith Alexander, from the Crouch End Chavurah Jewish Community, and Cllr. Sheila Peacock, one of our longest serving members. It welcomed as new members, Cllrs. Cathy Brennan and Anna Lawton, Rev. Stephen Aglinko, representing Baptist churches, Hasret Bozdogan, from the Alevi Cultural Centre, Miriam Ellen, a teacher at Highgate Wood School, Hannaa Mohabeer, teacher at Hornsey School for Girls, Dr S. Kajansivakumaran, chair of the Shakthivel Hindu Association, Judith Prinsley, from the local Jewish community (and a member of the Board of Deputies of British Jews), and Helen Spiby-Vann, representing the Church of England London Diocesan Board of Schools.

Four SACRE meetings were held during the year. The first and last – in September 2023 and June 2024 – were in person meetings at the Hornsey School for Girls, and those in November 2023 and March 2024 were conducted online. The last meeting, in June, was held in person to celebrate the work of the SACRE and of RE in the Borough. The highlight was a brilliant presentation of entries to the Spirited Arts competition conducted by the National Association of Teachers of Religious Education by students from Mulberry Primary School and Hornsey School for Girls. The secondary students from HSG were present to discuss their study of RE with Council members who were struck by their engagement and thoughtful reflections on the subject

The SACRE bid in 2023-24 for a Westhill Endowment Trust grant for a video project called "Living Voices" on different religion and world views, particularly focusing on the Alevi community in the borough. SACRE agreed a development plan and continued to monitor the delivery of RE in schools and support training for RE teachers in Haringey.

This report gives an account of the RE environment in Haringey and the work of SACRE in fostering the development of RE to the benefit of the schoolchildren of this diverse borough and the wider community.

#### (1b) Introduction: Overview Purpose of the report

Religion and worldviews remain significantly important in our richly diverse borough, nationally and globally. Religious Education is a valuable and enriching curriculum subject. It is important in its own right and makes a unique contribution to the spiritual, moral, social and cultural (SMSC) development of pupils and supports wider community cohesion. The Government is keen to ensure all pupils receive high-quality Religious Education.

The Education Act 1996, Section 391 (6) and (7) requires that each year the Standing Advisory Council on Religious Education (SACRE), from each Local Authority, will publish a report as to the exercise of its functions and any action taken by the representative groups on the Council during the last preceding year.

#### This entails:

- advising the Local Authority on Religious Education given in accordance with the Agreed Syllabus
- monitoring the provision and quality of Religious Education taught according to its Agreed Syllabus, together with the overall effectiveness of the syllabus
- providing advice and support on the effective teaching of Religious Education in accordance with the locally Agreed Syllabus
- providing advice to the Local Authority and its schools on methods of teaching, the choice of teaching material and the provision of teacher training
- in partnership with its Local Authority, considering whether any changes need to be made in the Agreed Syllabus or in the support offered to schools in the implementation of the Agreed Syllabus, to improve the quality of teaching and learning of RE
- offering advice to the Local Authority, and through the Local Authority to schools, concerning how an existing Agreed Syllabus can be interpreted to fit in with a broad, balanced and coherent curriculum.

# (1c) Haringey context statement: Religion in Haringey

Our 2023 – 2024 Haringey context statement is drawing on the analysis of the 2021 Census data that has been released on the ONS website.

Statement from the ONS Census 2023 analysis: 'In 2021, 31.6% of Haringey residents reported having "No religion", up from 25.2% in 2011. The rise of 6.4 percentage points was the largest increase of all broad religious groups in Haringey. Because the census question about religious affiliation is voluntary and has varying response rates, caution is needed when comparing figures between different areas or between censuses.

Across London, the percentage of residents who described themselves as having "No religion" increased from 21.0% to 27.1%, while across England the percentage increased from 24.8% to 36.7%. In 2021, 39.3% of people in Haringey described themselves as Christian (down from 45.0%), while 12.6% described themselves as Muslim (down from 14.2% the decade before). There are many






factors that can cause changes to the religious profile of an area, such as a changing age structure or residents relocating for work or education. Changes may also be caused by differences in the way individuals chose to self-identify between censuses. Religious affiliation is the religion with which someone connects or identifies, rather than their beliefs or religious practice.'

In addition, SACRE has been engaging with the Alevi community as local population intelligence reveals that there is a sizable Alevi community in Haringey, even though this does not show up as a named community worldview on the census data.

Haringey is a lively and diverse borough with a quarter of residents being under the age of 20. 70% of pupils come from ethnic minority backgrounds. Over one hundred languages are spoken by pupils attending Haringey Schools and 50% of these speak English as an additional language.

Haringey is one of the most religiously diverse Boroughs in the U.K.

#### (1d) Overview: Haringey SACRE Meetings 2023 - 2024

Every Local Authority has to convene a Standing Advisory Council on Religious Education (SACRE). Haringey SACRE convenes four times each year. It comprises of four statutory groups: Committee A, B, C and D members. \*\*\* Appendix A: Haringey SACRE Membership list

- O Thursday 7<sup>th</sup> September 2023- 5-6.30pm Face to face
- O Thursday 16<sup>th</sup> November 2023- 5-6.30pm Virtual
- O Thursday 21<sup>st</sup> March 2024 5 6.30 pm Virtual
- O Thursday 8th June 2024 5-7pm Face to Face celebration

Haringey holds four meetings annually. In 2023-2024 we held two virtual meetings and two face to face meetings including the June celebration meeting where we invited school children to attend the session at Hornsey Girls School at the HEP (Haringey Education Partnership) office. Attendance at the Haringey SACRE meetings is consistent and quorate, apart from in very rare unavoidable circumstances. We continue to ensure the membership reflects the demographic. The SACRE are aware of vacancies and are endeavouring to attract representation of as many of the religion and worldviews groups in Haringey. In 2023 - 2024 we identified a need to find a new Hindu representative, and associations are being approached. SACRE has also endeavoured to build stronger relationships with the Alevi community and has invited representation to formally become members of SACRE. We have welcomed new members to our team of committed and supportive volunteers from the community.

Our Chair of SACRE took on the role in June 2022: James Chiriyankandath, senior research fellow at the Institute of Commonwealth Studies in London. James has served on the SACRE as a Governor and has been a welcome contributor to discussion and decision making.

Each meeting follows an agenda format that aligns with the formal Annual Report documentation. This allows for transparency and keeps an accurate record of the meetings to summarise in the reporting process at the end of each year. 2023-2024 SACRE Annual Report uses the NASACRE template (October 2021) in line with national guidance. The Annual Report process is also one of reflection, and this raises areas of development that SACRE has identified on their active development plan. \*\*\* Appendix C: Development Plan

This is an ongoing process. Each Annual Report comments on areas that we aim to address and improve upon, whether this is attracting new membership, offering additional training and support to RE teachers and schools or reviewing issues that have arisen in the Agreed Syllabus. The minutes of the meetings accurately record these discussions and are sent to HEP to be added to the SACRE page on the HEP education pages.

#### 2. Religious Education Statutory Responsibilities

#### (2a) The Local Agreed Syllabus and RE in schools

The Awareness Mystery Value (AMV) Haringey Agreed Syllabus for Religious Education was last refreshed in 2020-2021, with a formal launch in schools in 2022. This triggered SACRE to raise the importance of a review being agreed by SACRE as from September 2024. The AMV Syllabus outlines the statutory requirements for planning, teaching and assessment procedures. The Agreed Syllabus documents are offered to all schools in the Borough.

The AMV syllabus focus is on 6 areas of 'Big Enquiry' that allow for 'deep teaching' and learning:

- 1. Beliefs, teachings and sources
- 2. Practices and ways of life
- 3. Forms of expressing meaning
- 4. Identity, diversity and belonging
- 5. Meaning, purpose and truth
- 6. Values and commitments

HEP commissioned the RE adviser 2022 – 2023 to support curriculum development in Haringey schools. As a result, a number of schools have benefited from 'surgery' style virtual support sessions, RE Network and specialist RE training for coordinators and teachers as well as full school staff training to launch new RE curriculums. The Borough is continuing to offer a series of termly training and support opportunities to the RE teachers. Each session has a focus on curriculum planning using the 'golden threads' of the Haringey AMV syllabus. The training opportunities are advertised on the Haringey website and are supported by the HEP team.

The Network training events also provide SACRE with an additional way of monitoring RE in schools and helps to steer the provision and support offered to schools to develop skills required to deliver high quality RE in the classroom.

SACRE is aware that some academies have adopted at least elements of the AMV locally Agreed Syllabus; intelligence gathered through contact with schools. Going forward it would be ideal to promote RE training and Network sessions with the wider Haringey academy community.

#### (2b) AMV Agreed Syllabus Updates

HEP continues to support the RE Adviser with any amendments that are required to the current AMV syllabus.

The AMV working party have been very mindful of the active national discussions in the RE community, and the review process has proactively aligned the updates with the Ofsted RE Review (May 2021) the THEOS Report from 2020, the REC, and reflects discussions within NATRE/ AREIAC/NASACRE. However, the current syllabus is now dated to some degree. Going forward SACRE is aware of the need to review the Agreed Syllabus.





#### (2c) Standards and monitoring of RE

Haringey SACRE continued the process of monitoring RE during the period of 2023 – 2024.

HEP identified a list of primary and secondary schools that SACRE were asked to monitor. This involved a website trawl, to seek evidence of the RE curriculum offered as well as hours taught. The exercise proved useful, and the SACRE intend to continue with the process. Ultimately SACRE will send out letters stating the information discovered, the areas of celebration and areas that may benefit from support.

During 2023-2024 SACRE had useful conversations with schools and teacher groups as well as encouraging presentations from teachers at the celebration event in June 2024. The last celebratory SACRE meeting of the academic year in June 2024 welcomed teachers and pupils from two local Schools. They shared with SACRE members "Our RE journey and why RE is important in our school", displaying RE class books, responding to questions from SACRE members, and engaging in open table discussion. SACRE members were impressed by the interest, knowledge and enthusiasm of the young students.

Mulberry Primary School and Hornsey School for Girls presented at the June 2024 SACRE.

The RE lead from Mulberry Primary explained how she had combined the SACRE-approved Awareness, Mystery, Value (AMV) curriculum and the Haringey Education Partnership (HEP) curriculum to create a programme of learning that pupils really enjoyed. All pupils at the school, from Reception to Year 6, receive between 45 minutes and 1 hour of RE teaching every week. The RE lead explained also that some teachers had previously been scared to teach RE because they lacked the necessary subject knowledge. She had resolved this by providing training, so that now teachers feel confident to answer any questions that pupils ask.

It was noted that the storytelling approach to RE encouraged by the HEP curriculum booklets was very successful and helps pupils to memorise content. The curriculum is adapted as necessary for pupils in the school's Provision for Autism.

Mulberry pupils understand that RE is not just a subject for the classroom, and the school takes part in a broad range of activities to help demonstrate this. For example, it is entering NASACRE's 'Spirited Arts' competition and recently hosted an Iftar meal during Ramadan. 110 parents attended, both Muslim and non-Muslim, and the event was so successful that the school intends to run it again next year.

The RE lead concluded the presentation by saying that pupils enjoyed sharing their understanding of different religions and talking about their own experiences at home and in their communities. They felt safe and happy to discuss such matters. They also enjoyed looking at artefacts from different religions and learning how to treat them with respect. RE helps to reduce stereotyping.

The RE lead from 'Hornsey School for Girls' Students told the meeting that they loved studying RE/RS. It was interactive and allowed them to learn about and discuss a broad range of subjects. The Year 10 students present, who were taking RE for GCSE, said they felt it was an important subject for their futures in a multicultural society and RE knowledge helps them to understand the lives and views of friends and colleagues, as well as to recognise subjects that are sensitive and need to be approached carefully. Students also noted that there was a lot of writing to do for RE, but they could take part in interesting debates and share their own opinions verbally as well.

Some said they liked lessons that focused on philosophy and morality, where there was no 'right' answer. Everyone agreed that they sometimes felt rushed, and it was hard to process everything they were taught. The RE lead said that since 2016 there had been an awful lot of RE content to cover at GSCE level. They said they had learned to understand other people better and to be tolerant and





openminded. They felt RE also helped them describe their beliefs, while being respectful of the beliefs of others. Their confidence to share their opinions had grown as they moved from Year 7 to Year 10. SACRE concluded the meeting by saying that they had been very impressed by the students' willingness to speak, listen and share. The subject had given them a good understanding of people and broad life skills that served as a great foundation.

SACRE continues to support improvements to RE within schools by listening to children and teachers and offering training and bespoke support.

#### **Monitoring of provision 2023- 2024 Primary Schools**

The SACRE HEP education link leads on the allocation of schools to the SACRE members that monitor the designated school websites for evidence of RE.

Members of SACRE have links with primary schools through their faith communities within the borough, and this enables the group to gather evidence of good practice. SACRE continues to offer training and support to schools via the HEP website allowing the RE Adviser to gather evidence of RE good practice and areas that require additional support.

The Haringey SACRE also has an established working relationship with the local Diocese and Diocesan Religious Education Advisers and this can provide a collaborative approach to the monitoring of RE provision.

SACRE receives HEP's ongoing support in sharing data relevant to this role.

# 2023- 2024 Monitoring of Secondary Schools:

Academies bring new challenges in terms of accountability. Haringey SACRE aspires to have positive working relationships with academies that continue to use the locally Agreed Syllabus. SACRE also monitors the Ofsted reports to note progress and excellence in SMSC and RE delivery as well as issues requiring support. This is ongoing.

# Ofsted Reports 2023-2024:

Currently the HEP lead for Statutory Services, Fay Jackson, acts as the conduit between the LA and SACRE. HEP keeps the SACRE informed of Ofsted inspections and HEP reports on comments related to religion and worldviews and SMSC that may require celebration or action.

Nationally the picture for RE reflects the overall picture and grading for a school. Mostly, the reports do not make specific reference to RE but report on social, moral, spiritual and cultural development.

SACRE and HEP monitor the reports for statements that celebrate good practice in RE as well as alluding to the school failing to meet statutory provision as far as religious education and collective worship is concerned.





#### (2d) Teacher training and materials and advice for schools

The HEP RE Adviser continues to offer school training and support opportunities. Commissioned projects including those linked to Research awards (Farmington/NASACRE/ Westhill/ CSGT) have been shared and offered to schools free of charge to increase engagement and interest in RE. The RE adviser has provided schools with materials to support them in improving their RE in schools e.g. Solution Not Sides.

Advice on RE, resources and materials to support the delivery of the AMV agreed syllabus, as well as RE in general, have been shared in the schools circular collated by HEP and added to the HEP education website. Curriculum grids have been produced to support schools with their planning around progression, sequential learning, 'golden threads' and intent, implementation and impact themes encouraged by the Ofsted review of May 2021. National materials such the THEOS report and animated clip about religion and worldviews and looking through 'lenses' has also been shared.

During this period HEP has once again offered a series of RE Network training session to schools. This is an area of development for SACRE.

The CPD and Network provision has been a major step forward in engaging with schools and the important curriculum changes nationally in RE. Sessions have been provided on the Ofsted Research Review and religion and worldviews including humanism.

#### (2e) Other information

**Withdrawals:** There have been no withdrawals brought to the attention of Haringey SACRE 2023 – 2024. HEP and SACRE provide information held on the HEP/SACRE area with regards to guidance on withdrawal procedures.

**Complaints:** Haringey SACRE has a role in investigating complaints against schools in relation to RE and Collective Worship. In 2023-24 there were no such formal complaints to deal with.

**Borough Advice:** SACRE provides advice to the Local Authority (Borough) through the RE Adviser, and the Lead Adviser for Statutory Services in Haringey Education Partnership, who brings concerns from schools and Governors to SACRE. SACRE in turn discusses the issues, responds proactively, and if required establishes small working parties and publishes requested advice.





## 3. Collective Worship Statutory Responsibilities

#### (3a) Standards and monitoring of Collective Worship

Collective Worship is highlighted on the Development Plan as an area of ongoing work in 2023-2024.

In 2022-2023 SACRE considered how best to monitor Collective Worship, and has resumed scrutinising Ofsted reports, conversations with schools, teacher groups and website trawls. SACRE may need to combine the monitoring of RE and Collective Worship in a more structured format 2024-2025.

#### (3b) Determinations: Haringey SACRE's Statutory Role 2023-24

Haringey SACRE has a statutory role in considering and granting determinations. What is Determination? The Education Reform Act of 1988 (sections 6, 7, 9, and 12) entitles schools to apply to the SACRE for a 'Determination'. This allows the school to adjust the legal requirements to enable collective worship of a different character to take place for **some** or **all** pupils in the school. Determinations are made where a school, on behalf of a group of parents, requests Collective Worship other than that set down by statute.

There were no determinations in 2023-24 for Haringey SACRE to consider.

SACRE and the RE adviser provide materials and guidance on the HEP education website as well as

shared materials in the Headteachers schools circular.

Collective Worship remains a key Development Plan area. Haringey HEP has not commissioned any formal training on Collective Worship or the Determination process for Headteachers, Governors and teachers in schools in this period. This should be considered a development area going forward. However, SACRE members continue to generously offer schools their time and expertise. Faith representatives offer to deliver assemblies, support curriculum planning and provide guidance to individual teachers. Currently this is not embraced widely by schools. SACRE aspires to have a more active support role with schools and teachers in the Haringey area.

#### 4. Links with National Bodies

NASACRE Conference and regular bulletins: Haringey SACRE was represented at the annual conference. The conference provided an opportunity for the RE Adviser to attend useful workshops on data, and the future of religious and worldviews education, all of which are useful in shaping the SACRE going forward. The new members of SACRE were also signposted to the NASACRE virtual 'New Members' training events programme.

NASACRE/Westhill application for funding: Haringey SACRE under the Chair's leadership applied for funding from Westhill to push further with the SACRE idea of collecting the voices of the community to support the Agreed Syllabus – with a particular focus on the Alevi community. This work would support an under resourced area and support teachers in schools with locally produced resources.





The SACRE bid in 2023-24 for a National Association of SACRE (NASACRE)/Westhill Endowment Trust grant has still not been announced at the time of this Annual Report (November 2024). SACRE will resubmit the bid to Westhill in February 2025.

**REC/NATRE:** Haringey has benefited from the data provided by the REC to help steer discussion, funding and raising awareness of the benefits of delivering high quality RE. This included workforce data provided by NATRE on percentage of RE time being offered in Haringey schools, and this has provided momentum to the monitoring of school websites in Haringey.

**Central faith and belief organisations:** Current Haringey SACRE members are often also representatives on other local interfaith style groups, and issues are raised, or SACRE is signposted to events at our SACRE meetings.

**AREIAC/ Culham:** The RE Adviser is on the AREIAC Executive, as well as representing Haringey at the London meeting. The meetings provide an excellent network of RE leads and the sharing of best practice and ideas for schools based in London. The Adviser also attended the AREIAC and conference this year, and this feeds back into the support that is provided to Haringey.

**RE-Hubs:** Members of SACRE have been invited to attend the local London REHubs in conversation sessions as well as accessing the national speakers training.

# 5. Local SACRE Links and SACRE involvement locally

**Dioceses:** Haringey continues to benefit from the attendance of a Diocesan link adviser at our SACRE meetings. The representative shares the work of the Diocese within local schools and provides a clear link to SACRE. We hope to work more closely with the Diocesan adviser going forward, especially with regards to primary training and monitoring of RE and Collective Worship. The SACRE are keen to have a partnership approach to providing school support, and a CPD session has been suggested.

Inter Faith Groups: The Haringey SACRE members bring a wealth of inter-faith network links to the forum. This benefits SACRE immensely and helps to keep the membership of SACRE well balanced. Going forward Haringey SACRE will continue to build these links, and it is hoped that members of the wider interfaith community will attend the SACRE schools' celebration event in June 2024.

Holocaust Memorial HMD: Haringey are fortunate to have very active links with the local Jewish community and organisations. This includes **G2G** that have provided support and training, sharing a presentation about the Holocaust with SACRE members. Haringey have shared their contact details with all schools. Holocaust Memorial Day with its annual varied focus and related themes enables schools to explore critical moral issues, investigate human behaviour, respond to inspirational stories and consider what it means to be a responsible British citizen. Two of our SACRE members are representatives on our local Holocaust Memorial Committee (Christian and Muslim).

**Governor/ Head teacher training:** Haringey SACRE also offers HEP access to Religious Education training to support Governors and Head teachers in meeting their legal requirement to provide high quality RE in schools.





# 6. Haringey SACRE's own arrangements (statutory responsibilities) including:

Professional and administrative support and how the LA supports the SACRE (clerking, adviser, links to council initiatives)

Haringey LA has commissioned Haringey Education Partnership (HEP) to manage the Haringey SACRE. Fay Jackson, HEP Lead for Statutory Services, has provided excellent support and guidance to our Religious Education Adviser. SACRE feels well supported by the HEP team. The HEP Lead for Statutory Services acts as the conduit between the LA and SACRE on issues such as finance, data and councillor representation. HEP employs a formal clerk, MG and CH have served SACRE during this period. Haringey LA, under the management of HEP, has continued to provide support to SACRE and its work to encourage the development of high-quality religion and worldviews, Religious Education and SMSC in schools.

SACRE has been working alongside HEP to update the SACRE website area, to raise the profile of SACRE and raise school awareness of the role and support that SACRE can provide them in school. This is ongoing.

#### Membership, representation & recruitment - quoracy, issues and successes with recruitment

HEP works in partnership with the chair and members of the SACRE to identify gaps with representation of the local faith communities and wider group membership. Going forward a succession plan has been discussed for the role of Chair to allow for a mentoring and shadowing process to ease transition. Meetings have been consistently quorate, apart from very rare and unavoidable occasions.

**Training for SACRE (and ASC) members:** All new members are invited to a training session that is delivered by the RE adviser at the end of formal SACRE meetings when required. In addition, NASACRE now offers national virtual training sessions that members have also been signposted to.

Finance given to SACRE for its work: The LA currently supports the funding of the Religious Education Advisers time, of twenty days a year. Finance is allocated to cover the role of the Religious Education Adviser, Jan McGuire, who provides specialist RE advice and governance support, writes the Government/ NASACRE annual reports and commissioned bids, attends AREIAC/ NASACRE/Culham/NATRE meetings or conferences and deals with day-to-day matters. In addition to the twenty days funding for the Religious Education adviser, Haringey (HEP) also fund work and attendance of meetings with the AMV Agreed Syllabus team. SACRE also has a very efficient and supportive paid clerk: Christine Hatt. SACRE is grateful for this support.
