The role of the SACRE

The SACRE is independent of the Local Authority and its main function is to advise the Local Authority upon such matters connected with religious worship in Community and Voluntary Controlled schools.

Also, it: -

- can require the Authority to review its current agreed syllabus.
- and must consider applications made by a head teacher that the requirement for collective worship in Community schools or Schools which have not been designated as having a religious character to be wholly or mainly of a broadly Christian character shall not apply to the collective worship provided for some or all of the pupils at that particular school.

The broad role of the SACRE therefore is to support the effective provision of Religious Education and collective worship in schools.

Meetings held:

19th October 2022 21st March 2023 28th June 2023

All meetings were held online principally by the Microsoft TEAMS platform. SACRE remains open to offers from faith groups who may wish to host meetings and a return to occasional face to face meetings is proposed for specific purposes such as visiting speakers.

New Agreed syllabus

As referenced in our last annual report Manchester SACRE's new Agreed syllabus produced by R E Today in cooperation with Tameside, Trafford, Salford, and Stockport became live on September 1st, 2022. This syllabus will remain current until 2027.

All Schools were issued with electronic copies of the new syllabus. The full syllabus is copyright and licensed to the five commissioning authorities however an abridged version is available upon request to the Local Authority.

SACRE working party.

To further develop the work of the SACRE a working party was established in spring 2023 with the aim of the SACRE membership taking a more active lead in the workstreams undertaken and to drive new initiatives. The first report from the working party was issued in June 23 and highlighted two initial key initiatives to take forward. These were the provision of a regular newsletter to

schools and a directory of places of worship for school visits. These initiatives were to be taken forward and will be reported on in more detail in the annual report covering academic year 2023-2024.

Member presentations

Humanist representative Martin Knowles gave a very useful and interesting presentation on the Declaration of Modern Humanism which was ratified at a conference in Glasgow in May 2022.

Greater Manchester Faith and Belief Panel

During the year Manchester SACRE has continued to engage with this body and our vice chair Cedric Knipe is also member of the panel. A second meeting was held online November 28th, 2022.

R.E Data

The resumption of school examinations in summer 2023 means that we can present the validated data at the end of this report. Validated data from 2022 is retained from last years report for comparison purposes.

SACRE communication with schools

Through the SACRE LA Officer schools continue to receive regular communications via the Children and Families Directorate School Broadcast Circular system. These communications include notification of events, requests for contact details and training /support materials from SACRE members or other faith organisations. A new communication expected during the 2023-2024 academic year will be the Northern R E Newsletter produced and shared by colleagues from Pennine Learning.

Provision of information for SACRE members

Manchester SACRE continue to be members of NASACRE, and all members have access details to the website, including the regular briefings. Members can view Inspection reports and any R E related comments via the OFSTED website.

SACRE membership

During the period covered by this report Manchester SACRE was pleased to welcome Pranab Bhadra, and Warren Elf representing the Hindu and Jewish faiths respectively.

Freedom of Information requests (FOI)

No FOI requests were received by SACRE.

Requests for a determination

SACRE did not receive any requests for determinations regarding Collective Worship during the period covered by this report. Any school wishing to explore the relevance of a determination (daily collective worship which is other than 'wholly or mainly of a broadly Christian character) in their context should contact SACRE via the local authority officer. Church schools are not eligible for a determination and for an academy wishing to apply for a determination the correct process is for the Trust to apply through the Education Funding Agency (EFA) to the Secretary of State.

Complaints concerning RE

There have been no complaints concerning RE.

Complaints concerning Collective Worship

There have been no complaints received about collective worship.

Finance

SACRE does not have a dedicated budget; however, the LA covers the costs of a professional clerk, meeting costs and the membership of NASACRE. The LA representative on SACRE has the authority to consider requests for financial support for SACRE activities and to authorise payment where funds exist and there is a clear benefit to the role of SACRE.
