1 st November 2022	 Pupil Conference Review 17th June HS shared the video footage from the Pupil conference. This enabled members to view the feedback from pupils that attended and also gave an overview of the day. The feedback was extremely positive.
	 New syllabus. Update re trial units. HS reported that they had an open meeting was held at the end of July were a school team came forward to trial the units and a second school came on board in September. Lots of CPD has taken place and there will be a will catch up mid- November. HS will contact the schools to get their feedback which is an integral part of the process. The schools have been invited to do one of the workshops at the launch and share their experience of the units with attendees .LF reported that they were on schedule and a meeting was held via zoom on 20th October to explain about QUEST for RE and to go through the Christmas units. 11 Primary schools attended the session. A separate meeting will be held with a Special school to see how they could adapt the Quest for RE at his school. The date for the joint launch for Primary and Secondary is 12th January 2023 at Ewood Park. Schools have been told to save the date and that more details will follow. 	4. Discussion took place regarding reprising the No More Knives initiative in two years' time. It was also proposed to look at key issues effecting BwD communities including county lines. 	 5. AAT reiterated that the Agreed Syllabus cost had been paid for from the SACRE budget. The annual subscription cost to schools will also be paid by the LA for this year, however it was noted that schools will have to pay for the annual subscription cost thereafter.
	6. Brief discussion took place around another pupil conference and suggestions to look at bringing schools of sanctuary together was discussed. HS added that they have made preliminary enquiries about two exhibitions that will be hosted in the North West for the first time. One is the Jewish experience and the other is a series of photos taken on a visit to Auschwitz. A meeting to look at the Holocaust exhibitions and workshops will be held tonight and HS will have more information to circulate after this meeting. It was noted that BwD have always supported Refugee and asylum seekers .JS reported that Pleckgate is an Anne Frank school and they will be inviting members of SACRE and primary schools to view their exhibition.

4. Agreed Syllabus representatives

Primary Lisa Fenton- All is going according to plan and the Blackburn schools are getting themselves organised with the syllabus. I have had regular contact with several of them so they are getting to know me which is good. There were a good half dozen of them at the recent RE coordinators conference which had a world faiths theme. They are now more than happy to have joint meetings with the Church schools within the LA and across the Diocese.I have responded to particular requests for help with LTP's and schools are trying out units across the school in prep for Sept. I am booked for staff meetings in a couple of schools. I have updated several of the units to ensure there is enough coverage of world faiths for all schools and will continue to work on this. I have also created a new series of documents to help BWD schools with planning – these were created in consultation with several of the RE leads.

- Schools of Sanctuary JE reported that there are a number of schools in BwD that are Schools of Sanctuary. He proposed that SACRE encourage all schools in BwD to become Schools of Sanctuary. AAT confirmed that this would included in the SACRE action plan.

3. SACRE Funded Initiatives

Holocaust Memorial Day





In January 2023 Blackburn with Darwen Standing Advisory Council on Religious Education SACRE worked in collaboration with Blackburn Diocese Board of Education, Blackburn Cathedral, the North East Religious Resources Centre and the Board of Deputies to host two exhibitions designed to give people the opportunity to learn about Jewish culture and customs.


- a. The 'Jewish Living Experience' was a touring exhibition that gave people an opportunity to experience Judaism through beautifully illustrated display panels and by handling authentic cultural artefacts. School groups also took part in educational activities that promoted experiential learning.
- b. They're only Pictures' was a thought-provoking exhibition of photographs of Auschwitz taken by an interfaith group on a recent visit. It focused on the impact of community dialogue on our understanding of dignity and mutual respect.

These two exhibitions gave our young people a fantastic opportunity to learn more about Judaism. With a small Jewish population, Blackburn with Darwen does not have a synagogue and so opportunities to learn about Judaism and the Jewish culture are limited. By working together, we were able to bring these exhibitions to the borough, around the time of Holocaust Memorial Day.

As well as hosting visits from local secondary school and sixth form pupils, the exhibitions were open to anyone in our local community who wanted to learn more about the Jewish faith.



What is the cost of freedom and faith?



Two full day pupil conferences were organised and run at Blackburn Cathedral on the theme of "What is the cost of freedom and faith?"

26th January 2023 Years 8 and 9 and on the 31st January 2023 for Years 12 and 13

To enable pupil and student to explore two significant exhibitions linked to expressions of faith, persecution and the right to freedom

The Conference objectives were as follows:

Years 8 and 9

- Empower children and young people to identify why and how people express their faith and what impact that has on them individually, their family and the local and global community
- Explore a quality religious education unit from the Blackburn with Darwen Agreed Syllabus at KS3 and engage with how it impacts on the delivery of the provision of religious education within the local borough.
- Inspire and exemplify new ways to deliver Judaism lessons in accordance with the Locally Agreed Syllabus for KS3 and illustrate how those units feed and contribute to a spiral curriculum

Years 12 and 13

- Empower students to identify what they consider to be the cost of freedom and their role in community cohesion and as a global citizen
- To enable students to explore two significant exhibitions linked to expressions of faith, persecution and the right to freedom
- Encourage students to connect to their prior knowledge and deepen their understanding to identify why and how people express their faith and what impact that has on them individually, their family and the local and global community
- Explore a quality religious education unit from the Blackburn with Darwen Agreed Syllabus at KS5 and engage with how it impacts on the delivery of the provision of religious education within the local borough.
- Inspire and exemplify new ways to deliver Judaism lessons in accordance with the Locally Agreed Syllabus for KS5 and illustrate how those units feed and contribute to a spiral curriculum


Positive and informative feedback was gathered from attendees on the following:




Key Stage 4



KS4 Attainment 2022 · Actual results


Religious Studies GCSE · 1020 pupils






Key Stage 5

5. Collective Worship

This year our SACRE have worked tirelessly again to review and relaunch the clear procedure already established, to ensure an efficient response to any request for determination. The procedure and protocol for dealing with any requests for determination is now in place. All maintained schools currently who have a determination or may need to renew have been identified. The RSC and ESFA have also been contacted to ascertain the status of worship included in the agreements of academies and free schools.

In Autumn Term 2023 the Chair of SACRE will implement the process of review with the identified maintained schools who wish to apply for a determination.

SACRE have not received any withdrawals by phase or complaints.

6. Links with other bodies

SACRE is a member of NATRE, NASACRE and members actively attend conferences. We are currently planning our CPD engagement for 23-24.

The Chair of SACRE was until recently the lead for School Effectiveness and SEND in Blackburn with Darwen and was previously teaching school lead and a system leader. As a School Effectiveness Officer she can and does promote SACRE.

In 2022-2023 the Chair has again been given opportunities to communicate with the headteachers to generate interest around SACRE through face to face meetings, termly presentations and bulletin inserts. There is a real "buzz and chat" around the potential for new developments.

Governors too are being kept informed via bulletin updates and Director's Reports.

7. Blackburn with Darwen, SACRE's local arrangements

At the beginning of the academic year 2020 the deputy director of children's services, Jo Siddle (now Director), made a firm commitment to re-establish a high quality SACRE, to ensure that the Local Authority was properly able to meet its statutory duties. To demonstrate this commitment, they have appointed a Clerk, Sharifa Valli to SACRE. They funded the independent consultant Dot Thomson and provide support for the website design and upkeep from IT services. Legal Support is also provided each meeting by either Paula Johnson, Solicitor, or Gillian Emmott, Solicitor, from Democratic Services. They have also allocated £15,000 as budget for 22-23 and again for 23-24.

Induction support will be provided each September to all new members who have joined and will be a refresher for existing members.
